ORDINANCE NO. 2116

AN ORDINANCE OF THE CITY OF PASADENA CALLING AND PROVIDING FOR THE HOLDING OF A SPECIAL ELECTION TO BE HELD IN SAID CITY ON THE 7th DAY OF JUNE, 1923, AND SUBMITTING TO THE QUALIFIED ELECTORS THEREOF A PROPOSITION FOR THE INCURRING OF BONDED INDEBTEDNESS AND A PROPOSITION FOR THE APPROVAL OF A CITY PLAN.

WHEREAS, the Board of Directors of the City of Pasadena, being the legislative body of said City, at its meeting held on the 18th day of May, 1923, by unanimous vote of all of its members, duly passed and adopted a resolution entitled "A Resolution of the Board of Directors of the City of Pasadena Determining that Public Interest and Necessity Demand the Acquisition, Construction and Completion by said City of Certain Municipal Improvements Constituting a City Plan", and Numbered 4554, and said Resolution was thereupon duly approved by the chief executive officer of the City, to-wit, the Chairman of the Board of Directors thereof, and was on the 21st day of May, 1923, duly published in the Pasadena Evening Post, a newspaper of general circulation printed, published and circulated in the City of Pasadena, a copy thereof being on file in the office of the City Clerk of said City, and which said Resolution is hereby referred to for further particulars; and

WHEREAS the City Planning Commission of the City of Pasadena at its meeting held on the 11th day of May, 1923, duly passed and adopted a resolution in words and figures as follows, to-wit:

RESOLUTION NO. 2.

A RESOLUTION OF THE CITY PLANNING COMMISSION OF THE CITY OF PASADENA APPROVING A CITY PLAN.

Be it resolved by the City Planning Commission of the City of Pasadena:

SECTION 1. That the municipal improvements hereinafter described, being a number of municipal improvements in one group, be and they are hereby approved as constituting a City Plan for the City of Pasadena, to-wit:

(a) The acquisition of land for and the construction and completion thereon of a building together with suitable appurtenances, grounds and approaches for City Hall purposes, said land being situate in the City of Pasadena, County of Los Angeles, State of California, and being more particularly described as follows:

Beginning at a point in the westerly boundary line of Lot 4, W. T. Vore Subdivision as per map recorded in Book 10, page 41, Miscellaneous Records of the County of Los Angeles, State of California, said point being distant 45.28 feet northerly from the southerly boundary line of said Lot 4; thence east and parallel with the said southerly boundary line of Lot 4, 70 feet to a point; thence north $77^{\circ} 33' 30''$ east to a point in the present westerly line of Euclid Avenue; thence northerly along the said present westerly line of Euclid Avenue to a point in the northerly boundary line of Lot 14, William Converse Subdivision, as per map recorded in Book 12, page 6, said Miscellaneous Records; thence westerly along the said northerly boundary line of Lot 14 to the northwest corner of said Lot 14; thence in a direct line to the northeast corner of Lot 9, Ogden's Subdivision, as per map recorded in Book 14, page 39, said Miscellaneous Records; thence westerly along the northerly boundary line of said Lot 9 to a point that is distant 150 feet easterly from the westerly boundary line of Lot 6, Ogden's Subdivision aforesaid; thence northerly and parallel with the said westerly boundary line of Lot 6 to a point in the northerly boundary line of Lot 8, Ogden's Subdivision aforesaid; thence in a direct line to the northwest corner of said Lot 8; thence in a direct line

to the northeast corner of said Lot 6; thence in a direct line to the northwest corner of said Lot 6; thence in a direct line to the southwest corner of said Lot 6; thence in a direct line to the northeast corner of Lot 1, Mrs. Boynton's Subdivision, as per map recorded in Book 34, page 73, said Miscellaneous Records; thence southerly along the easterly boundary line of Lots 1 and 2, Mrs. Boynton's Subdivision aforesaid, to the southwest corner of Lot 4, Mrs. Boynton's Subdivision aforesaid; thence westerly and parallel with the southerly boundary line of said Lot 1 to a point in the present easterly line of Marengo Avenue; thence southerly along the said present easterly line of Marengo Avenue to a point that is distant 67 feet northerly from the northerly boundary line of Wallace Bros. Subdivision, as per map recorded in Book 23, page 3, said Miscellaneous Records; thence easterly and parallel with the said northerly boundary line of said Subdivision, a distance of 295 feet to a point; thence southerly and parallel with the present easterly line of Marengo Avenue to a point in the said northerly boundary line of Wallace Bros. Subdivision; thence in a direct line to the northeast corner of Lot 5, Wallace Bros. Subdivision aforesaid; thence southerly along the easterly boundary line of said Lot 5 to a point in the present northerly line of Union Street; thence easterly along the said present northerly line of Union Street to a point in the easterly boundary line of Lot 3, W. T. Vore Subdivision aforesaid; thence in a direct line to the point of beginning.

Excepting therefrom any portion of a public street or alley included within the above described lands.

(b) The acquisition of land for and the construction and completion thereon of a building, together with suitable appurtenances, grounds and approaches, for Public Library purposes, said land being situate in the City of Pasadena, County of Los Angeles, State of California, and being more particularly described as follows:

Lots 13, 14, 15, 16, 19 and the south 60 feet of Lot 20 in Lot 5 of Plat of A. Minde's Subdivision of Lots 4 and 5, Block "C", San Pascual Tract, as per map recorded in Book 7, page 46, Miscellaneous Records of the County of Los Angeles, State of California.

Excepting therefrom any portion of any street or alley included within the above described lands.

(c) The acquisition of land for and the construction and completion thereon of a building, together with suitable appurtenances, grounds and approaches for use as a Municipal Auditorium and assembly and convention hall, said land being situate in the City of Pasadena, County of Los Angeles, State of California, and being more particularly described as follows:

Beginning at the southeast corner of Lot 11, J. G. Miller and I. G. Ziegler Subdivision, as per map recorded in Book 14, page 23, Miscellaneous Records of the County of Los Angeles; thence westerly along the southerly boundary line of said Subdivision to the southwest corner of Lot 5 of said Subdivision; thence in a direct line to the northwest corner of said Lot 5; thence in a direct line to a point in the southerly boundary line of Lot 3, Ziegler and Bunkers Subdivision, as per map recorded in Book 12, page 10, said Miscellaneous Records, said point being 18 feet westerly from the southeast corner of said Lot 3; thence northerly and parallel with the easterly boundary line of said Lot 3 to a point in the proposed southerly line of Green Street as said line is described in the Resolution of the Board of Directors of the City of Pasadena entitled 'A Resolution of the Board of Directors of the City of Pasadena Declaring that Public Interest and Necessity require the Acquisition of Certain Lands for the Opening, Widening and Extending of Green Street, a Street of the City of Pasadena', said proposed southerly line of Green Street being 84 feet northerly from and parallel with the northerly boundary line of Ziegler and Bunkers Subdi-

vision aforesaid; thence easterly along the said proposed southerly line of Green Street and parallel with the said northerly boundary line of Ziegler and Bunkers Subdivision aforesaid to a point in the easterly boundary line of Lot 4, Block "I", San Pasqual Tract, as per map recorded in Book 3, page 315, said Miscellaneous Records; thence southerly along the said easterly boundary line of said Lot 4 to the point of beginning; also

That portion of Wm. C. Dickinson's Subdivision, as per map recorded in Book 15, page 8, Miscellaneous Records of Los Angeles County, included within the following described exterior boundary lines, to-wit:

Beginning at a point in the northerly boundary line of Lot 3, said Wm. C. Dickinson's Subdivision, said point being at the southwest corner of Lot 5, J. G. Miller and I. G. Ziegler Subdivision, as per map recorded in Book 14, page 23, said Miscellaneous Records; thence southerly along the prolongation southerly of the westerly boundary line of said Lot 5 to a point in the northerly line of Henrietta Court, as said Court is shown on map of Wm. C. Dickinson's Subdivision aforesaid; thence easterly along the said northerly line of Henrietta Court to the easterly boundary line of Lot 7, said Wm. C. Dickinson's Subdivision; thence northerly along the said easterly boundary line of Lot 7 to the northeast corner thereof; thence westerly along the northerly boundary line of said Wm. C. Dickinson's Subdivision to the point of beginning.

Excepting therefrom any portion of a public street or alley included within the above described lands.

SECTION 2. That the City Plan hereinbefore approved be submitted to the electors of the City of Pasadena for their approval and that the Board of Directors of the said City be requested to so submit the said City Plan and also to submit to the said electors a proposition to incur a bonded debt in the sum of Three Million Five Hundred Thousand Dollars (\$3,500,000) for the purpose of carrying out

the said City Plan, said sum being the estimated cost thereof.

SECTION 3. The Secretary of the City Planning Commission shall certify to the adoption of this Resolution and shall cause a copy hereof to be transmitted to the Board of Directors of the City of Pasadena.

AND WHEREAS, a copy of said Resolution of the City Planning Commission, duly certified by the Secretary thereof, has been transmitted to and received by the Board of Directors of the City of Pasadena, and is now on file in the office of the City Clerk:

NOW THEREFORE, The Board of Directors of the City of Pasadena ordains as follows:

SECTION 1. DATE OF ELECTION. That a special municipal election be held and the same is hereby called to be held in the City of Pasadena on Thursday, the 7th day of June, 1923, for the purpose of submitting to the qualified electors of said City the proposition for incurring bonded indebtedness and issuing bonds of said City in the amount hereinafter set forth, and for the objects and purposes set forth in said Resolution No. 4554 and hereinafter stated, and submitting to the qualified electors of said City the proposition of approving the City Plan described in said Resolution of the City Planning Commission, hereinbefore set out.

SECTION 2. TIME OF OPENING AND CLOSING POLLS: The polls for said election shall be open at 6 o'clock in the morning of the day herein fixed as the day of said election, and shall be kept open until 7 o'clock of the afternoon of the same day when the polls shall be closed. Provided, however, that if at the said hour of closing

there are any voters in the polling place or in line at the door thereof who are qualified to vote but have not been able to do so since appearing, the polls shall be kept open a sufficient time to enable them to vote, but no one who shall arrive at the polling place after 7 o'clock in the evening shall be entitled to vote, although the polls may have been open when he arrived.

SECTION 3. FORM OF BALLOT: The ballot to be used at said election shall be printed in substantially the following form, and shall contain the statements of the two propositions to be submitted at said election in the following language:

INSTRUCTIONS TO VOTERS.

To vote on any proposition stamp a cross (X) in the voting square after the word "Yes" or after the word "No." All marks except the cross (X) are forbidden. All distinguishing marks or erasures are forbidden and make the ballot void. If you wrongly stamp, tear or deface this ballot, return it to the Inspector of Election and obtain another.

Proposition No. 1.

Shall the City of Pasadena incur a bonded debt of Three Million Five Hundred Thousand Dollars (\$3,500,000) for the purpose of the acquisition, construction and completion of certain municipal improvements in one group heretofore approved by the City Planning Commission of the City of Pasadena as constituting a City Plan, to-wit, the acquisition of land for and the construction and completion thereon of a building, together with suitable appurtenances, grounds and approaches, for City Hall purposes, and the acquisition of land for and the construction and completion thereon of a building, together with suitable appurtenances, grounds and approaches, for Public Library purposes, and the acquisition of land for and the construction and completion thereon of a building, together with suitable appurtenances, grounds and approaches, for use as a Municipal Auditorium and assembly and convention hall?

being delineated on two maps entitled "Precinct Map of Los Angeles County, Compiled by County Surveyor, January 1922, City of Pasadena, Eastern Portion", and "Precinct Map of Los Angeles County, Compiled by County Surveyor, January 1922, City of Pasadena, Western Portion", respectively, which maps are on file in the office of the City Clerk of the City of Pasadena, which said order of the Board of Supervisors and said maps are hereby referred to and made a part hereof, excepting Precinct No. 5 as set forth in said order and on said map, which last mentioned precinct is hereby consolidated with and made a part of Precinct No. 4 as set forth in said order and on said map, the precinct so created and consolidated to be known as Precinct No. 4, and also excepting Precincts Nos. 19 and 20 as set forth in said order and on said map, which said last mentioned precincts are hereby consolidated with and made a part of Precinct No. 78 as set forth in said order and on said map, the precinct so created and consolidated to be known as Precinct No. 78. That portion of the City of Pasadena generally described as the Avondale Tract, the annexation of which to the City of Pasadena was approved by Ordinance No. 2109, said territory being fully described in said ordinance, is hereby consolidated with and made a part of Municipal Election Precinct No. 49.

That the following are the polling places of said municipal election precincts for the election hereby called, and the following persons are hereby appointed officers of election and shall constitute the boards of election for each of said precincts, respectively:
