## SUBJECT: APPROVAL OF ANNUAL ADJUSTMENTS TO THE FISCAL YEAR 2017 SCHEDULE OF TAXES, FEES, AND CHARGES RELATED TO NEW YEAR'S DAY AND THE ROSE BOWL

## **RECOMMENDATION:**

- 1 Find that the proposed rate increases are exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3)
- 2 Approve the scheduled rate increases effective February 1, 2017 for the Grandstand Permit Application, the Rose Bowl Admission Tax, and the New Year's Day Related Business Grandstand Seat Surcharge as set forth in the body of this report

## BACKGROUND:

Pursuant to Pasadena Municipal Code Section 1 08 060 - the Rose Bowl Admission Tax, the Grandstand Seat Surcharge, and the Grandstand Permit Application Fee are to be adjusted on February 1st of each year The Code also states these taxes and fees are adjusted by an amount equal to the change in the Consumer Price Index (CPI) for the Los Angeles-Riverside-Orange County metropolitan area for the preceding 12-month period ending October 1st The change in CPI for all urban consumers in the Los Angeles Riverside-Orange County metropolitan area was 1 9207 percent between October 1, 2015 and October 1, 2016, accordingly, it is proposed that the Rose Bowl Admission Tax, the Grandstand Seat Surcharge, and the Grandstand Permit Application Fee be increased by a like amount on the Fiscal Year 2017 Revised Schedule of Taxes, Fees, and Charges as indicated below

This fee is charged for each seat in each grandstand designed or used for seating for a person viewing the Tournament of Roses parade

This tax is levied upon every ticket for admission to the Rose Bowl

#### **COUNCIL POLICY CONSIDERATION:**

The proposed actions are consistent with the City Council's Strategic Planning goals of maintaining fiscal responsibility and supporting and promoting the quality of life and local economy

#### **ENVIRONMENTAL ANALYSIS:**

This action is exempt from CEQA pursuant to State CEQA Guidelines Section 15061(b)(3), the General Rule The General Rule can be applied when it can be seen with certainty that the activity will not have a significant effect on the environment The proposed action is the modification of a tax or fee, and will not result in any new development or physical changes

#### FISCAL IMPACT:

Implementation of the proposed rate adjustments for the Grandstand Permit Application, the Rose Bowl Admission Tax, and the New Year's Day Related Business Grandstand Seat Surcharge would increase estimated revenues for Fiscal Year 2018 in the New Year's Day Event Fund by \$5,200 (10620024-603000), \$1,000 (10620024-618200-), and \$19,800 in additional revenue for the **Rose Bowl Operating Company** 

There is no fiscal impact to the Fiscal Year 2017 budgeted appropriations as a result of these actions nor will there be indirect or support cost requirements There is no anticipated impact to other operational programs or capital projects as a result of this action
