## **DECLARATION OF LANDMARK DESIGNATION FOR:**

## 1587 NORTH LOS ROBLES AVENUE PASADENA, CALIFORNIA

Pursuant to the provisions of Section 17.62.050 of the Pasadena Municipal Code, the City Council of the City of Pasadena by this declaration hereby designates as a Landmark certain real property described as:

THE LAND REFERRED TO HEREIN BELOW IS SITUATED IN THE COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AND IS DESCRIBED AS FOLLOWS:

### PARCEL 1

THAT PORTION OP BLOCK "L" OF SUBDIVISION OF LANDS BELONGING TO J. M. PAINTER AND B. F. BALL, IN THE CITY OF PASADENA. AS PER MAP RECORDED IN BOOK 4, PAGE 549, MISCELLANEOUS RECORDS OF SAID COUNTY DESCRIBED AS FOLLOWS, TO-WITT:

BEGINNING AT A POINT ON THE WEST LINE OF LOS ROBLES AVENUE 165 FEET NORTH OP THE SOUTHEAST CORNER OF BLOCK "L"; RINNING THENCE NORTH ALONG SAID WEST LINE OF SAID AVENUE 60 FEET; THENCE WEST 236 FEET; THENCE SOUTH SIXTY FEET; THENCE EAST TWO-HUNDRED THIRTY-SIX FEET TO THE POINT OF BEGINNING.
