CEREMONIAL MATTERS

The City Clerk administered the oath of office to Carolina Romo as a Northwest Commissioner.

PUBLIC COMMENT ON MATTERS NOT ON THE AGENDA

ON Dale Gronemeier, Coalition for Increased Civilian Oversight for the Pasadena Police (CICOPP), advocated for an independent review process for officer involved shootings prior to the City's completion of an administrative review.

Herminia Ortiz, United Neighbors, and Angelica Olivan, Pasadena resident, thanked Councilmember Gordo and the Pasadena Playhouse for the community play that promoted unity within the various cultures and ethnicities in the City.

Kris Ockershauser, American Civil Liberties Union (ACLU), requested that the administrative review process for the officer involved shooting that occurred on April 8, 2016 be postponed until the City Council makes a decision on an independent oversight model.

Consuelo Conizalez, Pasadena resident, expressed concern regarding the frequent parking citations issued by the City at her home address.

In response to Ms. Conizalez, the Mayor stated that the Transportation Department staff will review the issue and respond accordingly.

Michael Williams, Black Lives Matter, requested that the investigation of the officer involved shooting of Kendrec McDade be re-opened in order to conduct an independent review and audit.

David Llanes, Pasadena Police Officers' Association, expressed concerns regarding requests for an independent review board or auditor for the Pasadena Police Department, and suggested that the City Council instead focus on the insufficient number of Pasadena police officers currently employed by the City.

Ann Scheid, Civic Center Coalition, and Jonathan Edwards, Pasadena resident, asked staff to recirculate the Draft Environmental Impact Report (EIR) and expressed concerns regarding the proposed project.

David Reyes, Interim Director of Planning and Development, responded to the public comments by stating that preparation of the final EIR will be completed as part of the proposed approval of staff recommendations.

Following a brief discussion, it was moved by Councilmember Kennedy, seconded by Vice Mayor Masuda, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

The above three consent calendar items were discussed concurrently.

Councilmember Hampton reiterated his request that the City Council consider an amendment to the competitive bidding process in order to provide local vendors with a greater preference.

Councilmember Kennedy suggested that a list of potential Charter Amendment topics include providing Pasadena-based vendors a greater preference.

In response to Councilmember Kennedy's inquiry of City's staff outreach efforts to local vendors, Steve Mermell, Interim City Manager, responded that he would provide information regarding the Finance Department's various efforts supporting local vendors in the City Manager's newsletter.

The Mayor also requested information on reviewing local vendor preference practices, documenting outreach efforts, and various alternatives to provide additional advantages to local business.

Councilmember Gordo reiterated his concerns for amending the City's current procurement practices, citing potential unintended consequences that could lead to the "balkanization" of the region's commerce, resulting in negative economic impacts on Pasadena.

Following discussion, it was moved by Councilmember Wilson, seconded by Councilmember Gordo, to approve the staff recommendation for the three items noted above. (Motion carried, with Councilmember Hampton objecting) (Absent: None)

CONTRACT AWARD TO ITERIS INCORPORATED FOR CONSULTANT SERVICES TO DESIGN AND IMPLEMENT TRAFFIC SIGNAL SYNCHRONIZATION TIMING ALONG **BICYCLE DETECTION CORRIDORS**

Recommendation:

- (1) Find that the following proposed actions are exempt from environmental review pursuant to the California Environmental Quality Act ("CEQA"), pursuant to State CEQA Guidelines Section 15061(b)(3) (General Rule); and
- (2) Authorize the Interim City Manager to enter into a contract, without competitive bidding pursuant to City Charter Section 1002(F), contracts for professional or unique services, with Iteris Incorporated for an amount not-to-exceed \$133,485 for Consultant Services to Design and Implement Traffic Signal Synchronization Timing along Bicycle Detection Corridors. (Contract No. 30572)

Fred Dock, Director of Transportation, responded to questions regarding the cost efficiencies stated in the agenda report, raised by Councilmember Kennedy.

Following a brief discussion, it was moved by Councilmember Kennedy, seconded by Councilmember McAustin, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

FROM COUNCIL COMMITTEES

REPORTS AND COMMENTS APPROVAL OF MEASURES TO ADDRESS ASSOCIATED WITH HOMELESSNESS AND PANHANDLING Recommendation: It is recommended that the City Council take the following actions:

- (1) Find that the proposed actions are exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines, Section 15061(b)(3) (General Rule);
- (2) Direct the City Attorney to draft an ordinance that provides a definition for the following: "camping," "maintaining a camping

facility," and "lodging";

(3) Direct the City Attorney to draft an ordinance that establishes and describes the geographic boundaries of Pasadena Business Districts, including Old Pasadena District, Playhouse District, South Lake District, and the Hastings Ranch District, and prohibits within those geographic boundaries, during customary business hours, camping, maintaining a camping facility, or lodging on all public sidewalks, streets, alleys or other public spaces;

(4) Direct the City Attorney to draft an ordinance that prohibits, on all public sidewalks, streets, alleys or other public spaces, begging or soliciting of alms involving threatening, coercive, or

menacing behavior;

(5) Appropriate \$250,000 from the unappropriated fund balance in the Housing Successor Fund to the Fiscal Year (FY) 2016 Housing and Career Services Budget to provide for:

- a. Establishment of a Landlord Reimbursement Fund
- b. Expansion of the Homeless Prevention Fund
- c. Expansion of the Motel to Housing Voucher Engagement Program

d. Expansion of the Rapid Re-housing Program; and

(6) Consider adopting a policy statement supporting the development of permanent supportive housing broadly distributed throughout the City. (<u>Budget Amendment No. 2016</u>)

Councilmember Kennedy, Chair of the Public Safety Committee, introduced the item.

William Huang, Director of Housing, and Will Rivera, Chief Assistant City Prosecutor, provided a PowerPoint presentation, and responded to questions.

Councilmember Gordo expressed concerns with the recommended policy statement focused primarily on a supportive housing solution, preferring a broader approach in resolving the City's housing issues. He requested that staff provide an analysis on the distribution of affordable housing throughout the City. Mr. Gordo stated his preference that the proposed ordinance to prohibit camping and encampments include all the City's business districts as part of the geographic boundaries, and requested that staff also include freeways and public rights-of-way as part of the ordinance provisions. Finally, he suggested that staff also consider potential language restricting private property owners from allowing camping on private property without proper facilities and housing conditions.

Councilmember Wilson suggested that staff consider the feasibility of providing lockers for homeless individuals to store belongings in order to reduce the size of encampments and diminish blight.

Councilmember McAustin expressed support for permanent supportive housing distributed throughout the City to alleviate homelessness.

Vice Mayor Masuda, along with Councilmembers McAustin and Madison, voiced strong support for the funding of an additional Homeless Outreach-Psychiatric Evaluation (HOPE) team and voiced support for additional code enforcement provisions to address aggressive panhandling practices.

Councilmember Kennedy voiced his support for a policy statement on the importance of providing safe, affordable housing throughout the City.

Councilmember Hampton expressed concerns with the ability to enforce the proposed action and the potential consequences of criminalizing homelessness, stating his preference for a holistic approach to help address this issue. Mr. Hampton asked staff to review panhandling complaints and/or calls for service around Pasadena Unified School District school sites.

The following individuals spoke in favor of the staff recommendation and provided comments and/or suggestions on the proposed action:

Councilmember Wilson suggested that staff consider the impacts of homelessness on transit hubs, which may have a deterring effect on ridership, in order to protect the City's significant investment in public transportation.

Following lengthy discussion, it was moved by Councilmember Kennedy, seconded by Councilmember McAustin, to:

Approve Staff Recommendation Nos. 1, 2, 4, and 5, as proposed; amend Staff Recommendation No. 3, directing the City Attorney to draft an ordinance that establishes and describes the geographic boundaries of Pasadena [eliminating specific named districts and prohibits within those geographic boundaries, during customary business hours, camping, maintaining a camping facility, or lodging on all public sidewalks, streets, alleys or other public spaces, including and amend freeways and public rights-of-way; Recommendation No. 6, directing staff to return with a broad policy statement for City Council consideration with specific language to avoid the overconcentration of affordable housing in certain areas and provide permanent supportive housing throughout the City that is consistent with the City's adopted Housing Element and General Plan. (Motion carried, with Councilmember Hampton objecting) (Absent: None)

(4) Find that the project will not cause a significant adverse effect on a historical resource as defined in the State CEQA

(5) Based on these findings, approve the application for consolidated design review to demolish the house at 180 South Euclid Avenue.

Recommendation of the Design Commission: On November 24, 2015, the Design Commission denied an application for Consolidated Design Review for the demolition of the house at 180 South Euclid Avenue. The applicant appealed the Commission's decision on November 30, 2015. Prior to the City Council consideration of the applicant's appeal, the applicant submitted new information and on February 1, 2016, the City Council remanded the appeal to the Design Commission for a report on the new information submitted. The Design Commission considered the new information at its February 23, 2016 meeting and retained its previous determination that the house is a historical resource and that its demolition should be denied.
