CEREMONIAL MATTERS

- (1) Find the project in the agenda report to be categorically exempt under the California Environmental Quality Act (CEQA) State Guidelines in accordance with Title 14, Chapter 3, Class 1, Section 15301, minor alterations of existing public facilities involving negligible or no expansion of use beyond that previously existing at the time of the lead agency's determination; and
- (2) Accept the bid dated March 16, 2016, submitted by Slater Waterproofing, Inc., in response to the Project Specifications for the Arroyo Parkway Storm Drain Rehabilitation Phase 4 Project, reject all other bids received, and authorize the Interim City Manager to enter into a contract not-to-exceed \$268,000. - (2) Accept the bid dated February 17, 2016, submitted by Ramona, Inc., in response to the Project Specifications for the 2015-2016 Sewer Capacity Upgrades Project, reject all other bids received, and authorize the Interim City Manager to enter into a contract not-to-amount \$1,060,000. AUTHORIZATION TO AMEND CONTRACT NO. 22,305 WITH VCI UTILITY SERVICES DBA VANTAGE UTILITY SERVICES FOR UTILITY DISTRICT HILL AVENUE (VILLA STREET TO NORTH CITY LIMIT) PRIVATE PROPERTY OVERHEAD TO UNDERGROUND ELECTRIC SERVICE CONVERSION, FROM AN AMOUNT NOT-TO-EXCEED \$1,601,700 TO AN AMOUNT NOT-TO-EXCEED \$2,190,482 \$2,081,724. PUBLIC HEARING

<u>PUBLIC HEARING</u>: APPEAL OF DESIGN COMMISSION DECISION: CONSOLIDATED DESIGN REVIEW — DEMOLITION OF THE HOUSE AT 180 SOUTH EUCLID AVENUE (To be heard at 6:45 p.m., or thereafter)

Recommendation:

(1) Find that the demolition is exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (CEQA) (Public Resources Code Section 21080(b)(9); Administrative Code, Title 14, Chapter 1, Class 1, Section 15301, Existing Facilities). This exemption applies to demolition of up to three single-family residences or small commercial structures in urbanized areas;

(2) Find that no protected native, specimen, or landmark trees under the tree protection ordinance (Pasadena Municipal Code, Chapter 8.52) will be removed in conjunction with this

application;

(3) Find that the project is consistent with the purposes of design review and the Design Guidelines in the Central District

Specific Plan;

(4) Find that the project will not cause a significant adverse effect on a historical resource as defined in the State CEQA guidelines; and

(5) Based on these findings, approve the application for consolidated design review to demolish the house at 180 South

Euclid Avenue.

Recommendation of the Design Commission: On November 24, 2015, the Design Commission denied an application for Consolidated Design Review for the demolition of the house at 180 South Euclid Avenue. The applicant appealed the Commission's decision on November 30, 2015. Prior to the City Council consideration of the applicant's appeal, the applicant submitted new information and on February 1, 2016, the City Council remanded the appeal to the Design Commission for a report on the new information submitted. The Design Commission considered the new information at its February 23, 2016 meeting and retained its previous determination that the house is a historical resource and that its demolition should be denied.

The City Clerk opened the public hearing and reported 35 copies of the notice were posted, and 207 copies of the notice were mailed on March 24, 2016. The City Clerk's office received 132 letters of correspondence, with 5 letters expressing support for the staff's recommendation and the proposed project, 126 letters expressing opposition to staff's recommendation and/or concerns, and one letter providing suggestions, which were all distributed to the City Council and made part of the public hearing record.

David Reyes, Interim Director of Planning & Development, and Kevin Johnson, Senior Planner, provided a PowerPoint presentation regarding the agenda item; and responded to questions.

It was moved by Councilmember Gordo, seconded by Vice Mayor Masuda, to close the public hearing. (<u>Motion unanimously carried</u>) (Absent: None)

Councilmember Wilson stated his opposition to the staff's recommendation and suggested that if a demolition permit is approved, the approval include an agreement that the property maintains the essential characteristics of the buildings current facade.

Councilmember Hampton voiced his support in approving the building demolition but also supported the preservation of the building façade. In addition, Mr. Hampton requested that staff consider developing a formula in coordination with historical preservation groups, utilizing building structure, to deem a property as a historical structure.

Mayor Tornek and Vice Mayor Masuda expressed support for the Design Commission's decision to deny the application and spoke in opposition to the demolition of the house.

Councilmember McAustin stated her support of staff's recommendation and requested that staff require the developer to work with the Historic Preservation staff to preserve important elements of the building in the design and construction phase of the proposed project.

Councilmember Kennedy requested that the Design Commission appointment requirements be agendized for a discussion by the appropriate City Council Committee.

Councilmembers Kennedy, Madison, and Gordo spoke in support of the staff's recommendation, as well as the preservation of the building facade and other historically significant elements of the building.

Following discussion, it was moved by Councilmember Gordo, seconded by Councilmember McAustin, to open the public hearing. (Motion unanimously carried) (Absent: None)

Richard McDonald, Applicant/Appellant representative, clarified that a demolition approval can be conditioned to a scope of limitations and confirmed the willingness of the applicant to work with City staff to preserve historically significant elements of the building.

Following further discussion, it was moved by Councilmember Gordo, seconded by Councilmember McAustin, to continue the public hearing to May 16, 2016, 7:00 p.m., to allow for the developer and stake holders to meet with the City staff regarding the preservation of historically significant elements of the building. (Motion unanimously carried) (Absent: None)

PUBLIC HEARING: AMENDMENT TO THE ANNUAL ACTION PLAN (2015-2016) FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

Recommendation: It is recommended that upon close of the public hearing the City Council take the following actions:

- (1) Find that the recommended action is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines per Section 15061(b)(3), the General Rule that CEQA only applies to projects that may have an effect on the environment; and
- (2) Approve the submission to the U.S. Department of Housing and Urban Development of an Amendment to the Annual Action Plan (2015-2016) as described in the agenda report

The City Clerk opened the public hearing; reported that the notice of public hearing was published on March 17, 2016 and March 31, 2016 in the <u>Pasadena Journal</u>; no correspondence was received by the City Clerk's office regarding this item.

William Huang, Director of Housing, and Randy Mabson, Program Coordinator, provided a PowerPoint presentation on the agenda item; and responded to questions

Steve Mermell, Interim City Manager, and Ara Maloyan, Director of Public Works responded to questions regarding the City's sidewalk repair and improvements assessment program.

Councilmember Madison expressed concerns with utilizing Community Development Block Grant (CDBG) funds to fund the City's sidewalk repair and improvements program in the proposed locations detailed in the agenda report.

Councilmembers Madison and Hampton, and the Mayor suggested that the recommended sidewalk repair and improvements be completed in communities' with moderate incomes or in the northwest region of the City.

Councilmember Wilson stated that the CDBG funds should be utilized for The Americans with Disabilities Act (ADA) ramps and curb cuts required throughout the City and requested a copy of the map referred to in staff's presentation.

Following discussion, it was moved by Councilmember Kennedy, seconded by Councilmember McAustin, to continue the Public Hearing to April 25, 2016, 7:00 p.m. and for staff to return to the City Council with the suggestions detailed above. (Motion unanimously carried) (Absent: None)
