**PUBLIC COMMENT ON
MATTERS NOT ON THE
AGENDA**

Roger Roldan, Pasadena Police Officers Association, spoke on the officer involved altercation with Reginald Thomas, Jr. on September 30, 2016 and the Pasadena Police Departments' De-escalation Policy.

Steve Mermell, City Manager, reported that an inquiry into the death of Mr. Thomas is being conducted by the Los Angeles County Coroner's Office, the criminal investigation is being conducted independently by the Los Angeles County Sherriff's Department, an administrative review is in progress by the Pasadena Police Department, and an independent review of the altercation is to be conducted by a third party consultant.

Reverend Michael Burnes, Sr., Macedonia Missionary Baptist Church, spoke on the death of Reginald Thomas Jr. and expressed the need for stronger relations with the community, Pasadena Police, and elected officials.

Michael Williams, Black Lives Matter, spoke on the death of Reginald Thomas, Jr., and spoke against amending the Pasadena Municipal Code relating to camping in public parks and facilities, and the proposed prohibition in obstructing public right-of-way spaces.

Kelly Mercer, Pasadena resident, spoke on the death of Kenneth Mercer, which occurred on August 1, 2016, and spoke in favor of an independent review process in the Pasadena Police Department.

MUNICIPAL SERVICES COMMITTEE: AUTHORIZATION TO AMEND CONTRACT NO. 21,587 WITH CEDARWOOD YOUNG CORP., DBA ALLAN COMPANY TO PROCESS RECYCLING MATERIAL COLLECTED IN THE CITY OF PASADENA

Recommendation:

(1) Find that the proposed contract amendment is exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15061(b)(3); and

(2) Authorize the City Manager to exercise the first optional one year extension to Contract No. 21,587 with Cedarwood Young Corp., dba Allan Company, reducing the amount paid to the City for recycling material collected from the City of Pasadena's Curbside Recycling Program from \$35.50 per ton to \$10.00 per ton.

Recommendation of the Municipal Services Committee: On October 11, 2016, staff presented the proposed contract amendment with Allan Company to the Municipal Services Committee (MSC). The Committee supported staff's recommendations and voted to move the item forward for City Council's consideration. MSC recommended that staff include in the agenda report information regarding historical recyclable commodity pricing trends, curbside recycling collection totals and the status of other local cities' contractual pricing. PROPOSED SPEED LIMIT ORDINANCE REVISIONS

Recommendation:

- (1) Find that the proposed Municipal Code Amendment is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); and
- (2) Direct the City Attorney to prepare an amendment to Pasadena Municipal Code Section 10.48.010 (Prima facie speed of non-local streets) within 60 days that reflects the revisions presented in the agenda report.

Norman Baculinao, Traffic Engineering Manager, responded to questions regarding the posting of speed limit signs on Rosemont Avenue.

Following discussion, it was moved by Councilmember Hampton, seconded by Councilmember Wilson, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT WITH MARIPOSA LANDSCAPES, INC., TO FURNISH BRUSH CLEARANCE SERVICES FOR THE PASADENA WATER AND POWER DEPARTMENT

Recommendation:

- (1) Find that the project is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Sections 15301 (Existing Facilities); and
- (2) Accept the bid dated August 26, 2016, submitted by Mariposa Landscapes, Inc., in response to Specification WD-16-10 to furnish brush clearance services for the Pasadena Water and Power Department ("PWP"), and authorize the City Manager to enter into a contract with Mariposa Landscapes, Inc., for an amount not-to-exceed \$118,852 which includes \$29,713 for one year with three optional one-year terms, each year not-to-exceed \$29,713. The award includes an annual base cost of \$27,012 and an annual 10% contingency of \$2,701 to accommodate any necessary change orders. (Contract No. 30743)

Steve Mermell, City Manager, responded to Councilmember Hampton's inquiry regarding the capability and necessary qualifications of MASH workers to complete the services as required in the City's specifications for the project, as well as his concerns regarding the bid requirements for a C-27 California Landscape Contractor license, which may have deterred local landscapers from bidding on the project.

The Mayor stated that the contract is for one year with 3 optional one-year extensions, and that staff can return with an explanation as to why a C-27 California Landscape Contractor license is required.

Councilmember Kennedy asked staff to research the staff's bid requirement of a C-27 California Landscape Contractor license and report back to the City Council through the City Manager's newsletter as to whether there is a legal reason for such a requirement, and to research the possibility of providing the necessary training and licensing for in-house staff.

Following discussion, it was moved by Councilmember Kennedy, seconded by Councilmember Gordo, to approve the staff recommendation on a one year basis, with staff to provide the requested information prior to proposing any further extensions to the contract:

Councilmember Kennedy, Chair of the Public Safety Committee, reported on the Committee's discussions related to Pasadena Police staffing level concerns, with a recommendation from the Committee to be forthcoming to the City Council.

PUBLIC HEARING

PUBLIC HEARING: TEXT AMENDMENT TO ZONING CODE SECTION 17.40.100 TO BRING CONSISTENCY BETWEEN THE ZONING CODE AND THE EXISTING PUBLIC ART PROGRAM GUIDELINES FOR NEW PRIVATE DEVELOPMENT
Recommendation:

- (1) Find the proposed text amendment is exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines, Section 15308 (Class 8 – Actions by Regulatory Agencies for Protection of the Environment);
- (2) Adopt the Findings of Consistency (Attachment A of the agenda report);

(3) Approve the proposed text amendment to Zoning Code Section 17.40.100 to reinstate the intent of the City's Public Art Requirement, ensure that the City's Zoning Code is consistent with its Public Art Program Guidelines for New Private Development, and clarify the geographic boundaries of the Public Art Program; and

(4) Direct the City Attorney to prepare an ordinance within 60 days amending Title 17 of the Pasadena Municipal Code (Zoning Code), Section 17.40.100.

Recommendation of the Planning Commission: On September 14, 2016, the Planning Commission considered the staff recommendation to amend the Zoning Code, along with the environmental determination, as described in the agenda report. The Commission asked two questions to clarify the purpose and intent of the text amendment. At the conclusion of the public hearing, the Commission voted unanimously to adopt the staff recommendation, to be forwarded to the City Council.

Recommendation of the Arts and Culture Commission: On September 14, 2016, the Arts and Culture Commission considered the staff recommendation to amend the Zoning Code, as described in the agenda report. The Commissioners discussed the amendment and expressed support. At the conclusion of the public hearing, the Commission voted unanimously to adopt the staff recommendation, to be forwarded to the City Council.

The City Clerk opened the public hearing; reported that the public hearing notice was published in the Pasadena Journal and Pasadena Weekly on September 29, 2016, October 6, 2016, and October 13, 2016; no correspondence was received by the City Clerk's office regarding this item.

David Reyes, Director of Planning and Community Development, introduced the item, Julia Stewart, Assistant Planner, presented a PowerPoint summarizing the agenda report, and responded to questions.

Rochelle Branch, Cultural Affair Manager, responded to questions regarding the public art fees, and the process on the developers installing public art project on site.

RECOMMENDATIONS FROM OFFICERS AND DEPARTMENTS

MID-YEAR GENERAL FUND BUDGET REDUCTIONS AND DISCUSSION OF POTENTIAL FUTURE BUDGET ACTIONS

Recommendation: It is recommended that the City Council amend the Fiscal Year 2017 Operating Budget to implement General Fund expenditure reductions totaling \$2,113,057 as outlined in the Background Section of the agenda report. (Budget Amendment No. 2017-11)

Steve Mermell, City Manager, summarized the agenda report as part of the PowerPoint presentation, and responded to questions.

Horace Wormely, Director of Human Services, responded to questions regarding the Full-Time Equivalent (FTE) position that will not be filled, including potential impacts related to the reallocation of work duties and responsibilities that will be distributed among current staff.

Matt Hawkesworth, Director of Finance, provided an update on the City's Cost of Service study and analysis; and responded to questions regarding the City's present and future pension liabilities associated with the California Public Employees' Retirement System (CalPERS).

Councilmember Gordo requested that staff consider as part of the Cost of Service analysis a review of programs and positions that are responsible for securing private, federal, or state grant funds, which are important responsibilities.

Councilmember Hampton spoke against reducing funds from the Human Services and Recreation Department due to the close working relationship with Public Safety Officers.

Councilmember Madison expressed concerns with the City's practice in utilizing outside consultants for plan check services and asked staff to review the practice to determine if utilizing in-house staff provides cost savings. In addition, Mr. Madison asked staff to consider tax revenue measures if California Proposition 64, Marijuana Legalization (2016) is approved by the voters.

Councilmember McAustin expressed concerns with the proposed elimination of a maintenance assistant in the Parks Division due to public concern regarding the City's parks not being properly maintained.

Dale Gronemeier, Eagle Rock resident, distributed a handout on police population and spoke on the apparent over-funding of Police Department and public safety positions.

Laura Olhasso, Pasadena-Foothill Association of Realtors, asked the City Council to eliminate the occupancy inspection program for single-family homes.

Michelle White, Affordable Housing Services, spoke on the need to protect budget funds for the Housing Department.

Following discussion, it was moved by Councilmember Kennedy, seconded by Councilmember Hampton, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

ADOPTION OF A CITYWIDE POLICY STATEMENT ON PERMANENT SUPPORTIVE HOUSING

Recommendation: It is recommended that the City Council take the following actions:

- (1) Find that the adoption of the proposed Citywide Policy Statement on Permanent Supportive Housing is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3) (General Rule); and
- (2) Adopt a policy statement on permanent supportive housing, as set forth in the agenda report.

William Huang, Director of Housing and Career Services, summarized the agenda report as part of his PowerPoint presentation, and responded to questions.

Councilmember Kennedy asked staff to remove from the proposed Permanent Supportive Housing statement, "with an initial focus on locations where there is a persistent presence of unsheltered homeless persons", to ensure equitable distribution within the City.

Councilmember Gordo requested that staff develop a heat map that provides comprehensive affordable housing information and includes: Section 8 Housing Choice Voucher Program, permanent supportive housing, and deed-restricted affordable housing units, in order to better understand and illustrate over-concentration of affordable housing in certain neighborhoods. In addition, he requested that staff develop specific "over-concentration" criteria to be used to consider future project approvals that will provide a guide to staff and the community.

Vice Mayor Masuda requested that as part of the updated map to be developed by staff, information be included that also shows inclusionary and affordable units under construction.

Reverend Hanna Petrie, Greater Pasadena Area Housing Group (GPAHG), spoke on the award winning housing project in Pasadena, housing programs, and homelessness issues.

Jill Shook, GPAHG, spoke in favor of staff's recommendation and requested stronger language to require affordable housing in all City districts.

Michelle White, Affordable Housing Services, spoke in favor of permanent supportive housing in the City, and recommended that the proposed City Policy statement identified in the staff report read as follows, "Therefore, consistent with the Housing Element, the City of Pasadena will facilitate a balanced geographical dispersal of affordable housing, including permanent supportive housing throughout the City."

Motion:

Following discussion, it was moved by Councilmember Hampton, seconded by Councilmember Kennedy, to approve the staff recommendation, including the following amended language to replace the recommended policy statement on Permanent Supportive Housing, as was set forth in the agenda report: "The City of Pasadena believes that decent, safe and affordable housing is the right of every Pasadena resident. Furthermore, a key long-term solution for homelessness is the provision of permanent supportive housing. Therefore, consistent with the Housing Element, the City will facilitate a balanced geographical dispersal of affordable housing, including permanent supportive housing throughout the City." (Motion unanimously carried) (Absent: None)

Motion:

Following further discussion, it was moved by Councilmember Hampton, seconded by Councilmember Gordo, to direct staff to develop and identify specific criteria to address the over-concentration of affordable housing projects, with the criteria to consider all forms of affordable housing including: Section 8 Housing Choice Voucher Program, permanent supportive housing, and deed-restricted affordable housing units, as well as those units identified as affordable housing under construction. (Motion unanimously carried) (Absent: None)

William Huang, Director of Housing and Career Services, and Will Rivera, Chief Assistant City Prosecutor, responded to questions regarding enforcement and the concerns raised by public speakers.

The Mayor expressed concerns with the proposed Sections D and E of the ordinance, which identifies primary commercial corridors that may cause unintended consequences.

Councilmember Madison spoke in favor of the ordinance as written due to the numerous daily complaints regarding aggressive panhandlers.

Councilmember McAustin echoed the Mayor's concerns regarding the elimination of Sections D and E of the proposed ordinance and stated the need to devote additional resources to the Housing Department to address the chronically homeless population.

Councilmember Wilson suggested deploying additional "Real Change Movement" program meters throughout the City.

Following discussion, the proposed ordinance was amended by eliminating subsections D and E from Section 2, Title 12. Chapter 12, Section 12.12.080, with said amended ordinance offered for first reading by Councilmember Kennedy:

**HONDA COMMUNITY RECREATION LOOP IN AREA H
Recommendation of Rose Bowl Operating Company:**

- (1) Find that the actions proposed in the agenda report are exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15301 (existing facilities-minor);
- (2) Approve the naming of the new perimeter loop project in Area H for philanthropic contributions made to Legacy Connections, and physical improvements thereto, as "Honda Community Recreation Loop"; and
- (3) Approve two (2) donor recognition signs for the new perimeter loop project on Area H for contributions made to Legacy Connections by donors to this project.

Daryl Dunn, General Manager of the Rose Bowl Stadium, summarized the agenda report as part of the PowerPoint presentation; and responded to questions.

Councilmember Kennedy cited issues with previous signage recognizing donations to the Rose Bowl (e.g. the Wescom sign), and stated his strong preference that any design for the proposed signage be of the highest quality and caliber reflective of Pasadena and the Rose Bowl.

Councilmember Madison acknowledged the extraordinary gift from the Rose Bowl Legacy Connections, voiced support for the proposed action, but stated the need to clarify the various competing policies (i.e. Master Plan, naming rights, etc.) to avoid future confusion.

Councilmember McAustin requested that the proposed asphalt trail be replaced with natural products, such as decomposed granite, if possible.

Nina Chomsky, Linda Vista-Annandale Association, spoke in opposition to the RBOC recommendation, and asked that the signs be subject to a public review.

Councilmember Wilson suggested that the RBOC request that the Area H Perimeter project include maintenance responsibility.

Following discussion, it was moved by Councilmember Hampton, seconded by Councilmember Madison, to approve the Rose Bowl Operating Company's recommendation, amended to require that the approval process for the proposed signage include the Design Commission's review. (Motion unanimously carried) (Absent: None)

COUNCIL COMMENTS

The Mayor requested that the City Manager work with the Rose Bowl Operating Company to provide information on the operation and management of the Arroyo Seco, and develop recommendations and potential policies for City Council discussion and consideration at a future meeting.

Councilmember Kennedy spoke on the statement made by Terrence M. Cunningham, President of the International Association of Chiefs of Police, regarding the law enforcement profession and admission of historical injustices against people of color, and asked the City Clerk to distribute an article from the Washington Post to the City Council.

Councilmember Wilson and the Mayor spoke on and provided information regarding, Astronomy Week in Pasadena, October 16-22, 2016, the Pasadena Astronomy Festival, October 22, 2016, and Connect Week, October 16-23, 2016.

In response to Councilmember McAustin's inquiry regarding an update on a list of available properties for parks and open space ("Pocket Parks") in the Central District, City Manager Mermell responded that he recently met with Public Works Department staff to review possible locations, and will present information to the City Council in the coming weeks.
