# PUBLIC COMMENT ON MATTERS NOT ON THE AGENDA

Herminia Ortiz and Martha Vasquez, Vecinos Unidos Asocciacion, expressed concerns with the voting process at Villa Parke Community Center, on election day Tuesday, November 8, 2016

In response to public comment and Councilmember Gordo's inquiry, the City Clerk explained that the concerns were related to a malfunctioning ballot card counter used to audit the number of voted and un-voted ballot cards at the identified polling site, that the poll workers appropriately hand-counted the ballot cards, and clarified that the tabulation of votes occurred, as normal, at the Los Angeles County Registrar-Recorder's Offices in Norwalk, CA He also noted that he will organize a meeting with concerned residents and the County to better explain the process that occurred

Thomas Young, Pasadena resident, requested assistance with transients who are camping near Orange Grove Boulevard and Holly Street, and was directed by Caltrans employees to contact the City of Pasadena for additional assistance

The City Manager responded that he will work with the Police Department and the California Department of Transportation (Caltrans) to respond to Mr Young's concerns

The building and accessory structures are a locally significant, intact examples of a single-family residence property type built in Mediterranean Renaissance Revival style, designed by two USC trained designers, Frank W. Green and Frederick Hageman, and retain integrity,
- (3) Adopt a resolution approving a Declaration of Landmark Designation for 1600 San Pasqual Street, Pasadena, California,
- (4) Authorize the Mayor to execute the Declaration of Landmark Designation for 1600 San Pasqual Street, Pasadena, California, and
- (5) Direct the City Clerk to record the declaration with the Los Angeles County Recorder (Resolution No 9537)

Recommendation of the Historic Preservation Commission: At its regular meeting of July 19, 2016, the Historic Preservation Commission recommended that the City Council approve the designation of the house and accessory structures at 1600 San Pasqual Street as a Landmark under Criterion "C" of Pasadena Municipal Code Section 17 62 040

Councilmember Kennedy noted corrections to the staff agenda report, on Page 5, last paragraph, "California Avenue" should be changed to "California Boulevard", and Page 8, first paragraph, "Chaffers" should be changed to "Chauffer"

Councilmember Kennedy left at 8 31 p m
