<u>PUBLIC HEARING</u>: SUBMISSION OF PUBLIC HOUSING AGENCY ANNUAL PLAN (2016) TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT

Recommendation: It is recommended that the City of Pasadena as Successor Agency to the Pasadena Community Development Commission (the "City"), after a public hearing:

- (1) Find that the action proposed in the agenda report is exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15061(b)(3), as it will not have a potentially significant environmental effect, and therefore, falls under the "general rule" exemption; and
- (2) Approve the City's Public Housing Agency Annual Plan (2016), and authorize the Interim City Manager to execute any and all documents regarding its submission to the U.S. Department of Housing and Urban Development (HUD).

The Secretary opened the public hearing; reported that the notice of public hearing was published in the <u>Pasadena Journal</u> on December 24, 2015. No correspondence was received by the City Clerk's office regarding this item.

William Huang, Director of Housing, and Myrtle Dunson, Housing Assistant Officer, provided a PowerPoint presentation on the agenda item, and responded to questions.
