



## PUBLIC NOTICE

The **Official Street Tree**, according to the City's **Master Street Tree Plan**, for the sections of **Emerson Street** (between N Mentor Avenue to N Wilson Avenue) and for **Medford Road** (between E Sierra Madre Boulevard and the Dead End [Don Benito School]) is being proposed to be replaced.

The current Official Street Tree, Silver Maple tree, has been identified by the Department of Public Works as a poor performing tree species. As such, the Department is proposing to replace Silver Maple tree along **Emerson Street** with one of the following trees species:

Crape myrtle *Lagerstroemia indica*; Pink trumpet tree, *Handroanthus heptaphyllus*; or Chinese pistache tree *Pistacia chinensis*,

Silver Maple tree is being proposed to be replaced along **Medford Road** with one of the following tree species:

Fern pine, *Afrocarpus gracilio*; Deodar cedar, *Cedrus deodara*; or Brisbane box, *Lophostemon confertus*.
