SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2018 GENERAL FEE

SCHEDULE

RECOMMENDATION:

It is recommended that the City Council adopt a resolution amending the Fiscal Year (FY) 2018 General Fee Schedule as detailed in the "Proposed Fee Schedule" Amendments" section of this report.

BACKGROUND:

The General Fee Schedule includes all charges established based on the cost to provide the service such as processing land use approvals and building permits, as well as entrepreneurial type activities such as facility rentals. The General Fee Schedule was last updated and adopted by resolution on July 17, 2017.

While the General Fee Schedule is typically reviewed and updated annually, revisions may be made periodically throughout the year as the need may arise. The Planning and Community Development Department is proposing one new fee and revisions to four existing fees. Likewise, the Fire Department is proposing a revision to one existing fee.

Proposed Fee Schedule Amendments

- 1. New "Public Hearing Notice Sign" Fee The Planning and Community Development Department proposes a new "Public Hearing Notice Sign" fee of \$11.50. The Department processes applications for new private development throughout the City and it is required that the developer or applicant post a 24" x 36" noticing board in the event that the proposed development requires a public hearing. Currently, no fee is collected for this service. The new fee will recover the costs to purchase the board and for the City's Print Shop to print each sign.
- 2. Amend Existing Pass-Through Fees The Planning and Community
 Development Department recommends amending the pass-through fees below
 to reflect the California State Department of Fish & Wildlife and Los Angeles (LA)
 County Registrar-Recorder/County Clerk mandated rates.

3. Amend Existing "EMS Transport" Fee – The Fire Department recommends amending "EMS Transport" fee from \$1,900.00 to \$2,108.00 to align with the allowable County of Los Angeles General Public Ambulance rates. The fee recovers equipment and personnel costs utilized for patient transports to hospitals on medical incidents.

COUNCIL POLICY CONSIDERATION:

The City Council's strategic planning goal of maintaining fiscal responsibility and stability will be advanced through the periodic review and update of the General Fee Schedule and by ensuring that, where appropriate, the City is reimbursed for the cost of providing selected services.

FISCAL IMPACT:

It is anticipated that the proposed amendments to the General Fee Schedule will result in approximately \$116,200 in annual revenue to the General Fund.
