CEREMONIAL MATTERS

The City Clerk administered the oath of office to Norma Fernandez as Commissioner on the Status of Women.

PUBLIC COMMENT ON MATTERS NOT ON THE AGENDA

Nina Chomsky, representing the Linda Vista-Annandale Neighborhood Association, expressed concerns with the proposed Area H improvement project adjacent to the Rose Bowl and what can be perceived as the commercialization of the Central Arroyo, and requested further review and discussion by the City Council.

The Mayor asked the City Manager to provide an update on the project and requested information on the Rose Bowl Operating Company's (RBOC) jurisdiction outside of the fence line surrounding the Rose Bowl (also known as the Rose Bowl grounds).

In response to the Mayor and the public speaker, Councilmember Gordo, RBOC President, provided additional information on the RBOC's consideration and discussion regarding the proposed project.

Dominick Correy, newly appointed District Representative for Senator Anthony J. Portantino, introduced himself and provided a brief description of his responsibilities.
