SUBJECT: OPENING OF PUBLIC HEARING FOR THE FISCAL YEAR 2018 RECOMMENDED OPERATING BUDGET

RECOMMENDATIONS:

It is recommended that the City Council:

- 1. Open the public hearing for the Fiscal Year 2018 Recommended Operating budget; and
- 2. Continue this public hearing to each subsequent regular meeting of the City Council at 7:00 p.m. until June 19, 2017 or such other date as the City Council may determine, and at which time the City Council will be asked to close the public hearing and adopt the Fiscal Year 2018 Recommended Operating Budget.

BACKGROUND:

Section 902 of the City Charter requires that on or before the third Monday in May the City Manager shall submit an annual operating budget. The recommended budget represents the City's financial plan for FY 2018 and furthers the City's mission to deliver exemplary municipal services responsive to our entire community and consistent with the City's history, culture, and unique character.

In addition to the City's anticipated operating revenues and expenses, the FY 2018 Recommended Budget includes the appropriations for the FY 2018-2022 Capital Improvement Plan and the City's affiliated agencies (Rose Bowl Operating Company, Pasadena Center Operating Company, and Pasadena Community Access Corporation).
