SUBJECT: CANVASS OF THE APRIL 18, 2017 GENERAL MUNICIPAL ELECTION

RECOMMENDATION:

It is recommended that the City Council:

- (1) Accept the Certificate of Canvass (Exhibit A of the resolution); and
- (2) Adopt a resolution declaring that Andy Wilson is elected as member of the City Council, District 7.

BACKGROUND:

The City of Pasadena held its Primary Nominating Election on Tuesday, March 7, 2017, for the members of the City Council, Districts 3, 5, and 7. Pasadena City Charter, Section 1204, provides that, "Any person who, at the primary election, shall receive a majority of the total votes cast for candidates for said office shall be elected to such office."

At the March 7, 2017 Primary Nominating Election, City Council District 3 candidate John J. Kennedy, and District 5 candidate Victor M. Gordo, each received the majority of votes cast from their districts, and were re-elected as members of the City Council, Districts 3 and 5, respectively.

In the Council District 7 race, of the five qualified candidates running for this office, no candidate received the required 50 plus one majority of the total votes cast. The two candidates with the highest number of votes received were Andy Wilson and Phil Hosp, and in accordance with Charter Section 1204, the two candidates with the highest number of votes cast for the respective office had their names placed on the ballot for the General Municipal Election held on April 18, 2017.

WHEREAS, a General Municipal Election was held and conducted in the City of Pasadena on April 18, 2017, for the member of the City Council, District 7, as required by Sections 1204 and 1205 of the Pasadena City Charter; and

WHEREAS, the votes at said election have been canvassed by the City Clerk and a copy of said canvass is attached hereto as Exhibit A, and incorporated herein by reference; and

WHEREAS, said City Clerk has certified the results of said canvass to the City Council of the City of Pasadena.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pasadena that:

1. The following be declared to be the results of said General Municipal Election for the Office of member of the City Council, District 7:

Andy Wilson 1,793 votes (50.5%)
Phil Hosp 1,757 votes (49.4%)

2. That Andy Wilson, having received a majority of the total votes cast for candidate for the office of member of the City Council from District 7, from which the candidate sought nomination, hereby is declared to be elected as member of the City Council from District 7, for a full term of four years.
