AND ALIGN WITH CURRENT PARKING PRACTICES

#### TITLE OF PROPOSED ORDINANCE:

AN ORDINANCE OF THE CITY OF PASADENA AMENDING PASADENA MUNICIPAL CODE TITLE 10, CHAPTERS 10.08, 10.40, 10.41, 10.42, 10.44 AND 10.45 AND TITLE 12, CHAPTER 12.14 TO CONFORM WITH CURRENT DEPARTMENTAL RESPONSIBILITIES AND ALIGN WITH CURRENT PARKING **PRACTICES** 

#### PURPOSE OF ORDINANCE:

Changes in departmental responsibilities with respect to parking operations, and changes in parking meter technology require that Title 10 and Title 12 of the Municipal Code be updated to reflect these changes

#### REASON WHY LEGISLATION IS NEEDED:

Parking regulations are codified within Title 10 and Title 12 of the Pasadena Municipal Code and they can only be amended by ordinance

#### BACKGROUND

On January 23, 2017, the Council directed the City Attorney to draft an ordinance to update Chapter 10 and Chapter 12 of the Pasadena Municipal Code. On February 6,

2017 an amendment that needed to be promptly addressed relating to certain aspects of parking meter operation was presented to the Council. This ordinance will address all the remaining amendments necessary to align the Code with current parking practices and departmental responsibilities.

### PROGRAMS, DEPARTMENTS OR GROUPS AFFECTED:

The Parking Division of the Department of Transportation oversees all aspects of parking operations.

There is no fiscal impact as a result of this ordinance amendment.
