ADMINISTRATION OF OATHS OF OFFICE

The City Clerk administered the oaths of office to re-elected Councilmembers John J. Kennedy and Victor M. Gordo, and newly-elected Councilmember Andy Wilson.

STATEMENTS BY NEW AND RE-ELECTED COUNCILMEMBERS Councilmember Gordo thanked the voters of District 5, his family, colleagues, and City staff; expressed honor and gratitude for the support he received as candidate and Councilmember representing District 5; and spoke on the challenges he believes the City will be facing in the near future and the need for unity and cooperation in solving these issues.

Councilmember Kennedy thanked the residents and voters of District 3, for their support and confidence in his ability to serve as their representative on the City Council and spoke on the various issues he believes the City can resolve by working together and avoiding divisiveness. In addition, Mr. Kennedy introduced and thanked his district liaisons, family and guests in the audience.

Councilmember Wilson spoke on his campaign journey and his desire to work towards a brighter future as one united City; and expressed gratitude to the residents and voters of District 7, family, donors, his campaign staff, and volunteers.

The Mayor presented Vice Mayor Masuda with a token in appreciation and admiration for his service as the City's Vice Mayor.

Vice Mayor Masuda expressed appreciation to his wife and his constituents, and congratulated Councilmembers Gordo, Kennedy and Wilson on winning their respective elections.

**ELECTION OF VICE MAYOR** 

The Mayor opened nominations for Vice Mayor.

It was moved by Councilmember McAustin, seconded by Councilmember Madison, to nominate John Kennedy as Vice Mayor for a term of one year. There being no further nominations, the Mayor declared the nominations closed, and directed the City

Clerk to conduct a roll call vote, as follows:

Vice Mayor Kennedy requested that the following be included as part of the record:

"Most importantly, I humbly and gratefully begin by paying homage to my parents, Leola Sudduth and Thomas Foster Kennedy who reared 10 children together in Pasadena. They are observing this ceremony from a beautiful vista called heaven.

This call to service as Vice Mayor is of tremendous personal significance to me as a life-long resident of this City. The first African American elected to the Pasadena City Council was the Honorable Henry (Hank) Wilfong. I worked on his election campaign in 1973, and he was highly-respected. Mr. Wilfong never served as Vice Mayor. The second African American elected to the Pasadena City Council was the Honorable Loretta Thompson-Glickman. In 1981, Loretta was chosen as Vice Mayor, by the then Council. She served honorably as Vice Mayor and then as Mayor. The Honorable Chris Holden followed in her footsteps. I recognize them all as trailblazers, and I am grateful to each of them as mentors and as friends.

With gratitude, I accept this role as Vice Mayor of all of the people of Pasadena. I shall honor all of those who preceded me in this important role, from the Honorable Gene Masuda to the Honorable Jacque Robinson, to their predecessors through our City's history. While our local elections tend not to be as divisive as our national elections, they can be divisive nevertheless. We have many critical issues to address as a City, and we need to put divisions aside so that we can succeed together as a City Council and succeed on behalf of our constituents to ensure that all of Pasadena residents have maximum quality of life and the fullest measure of opportunity. I need not remind anyone that it is our obligation to get along, to be forthright with one another, and to bring our different views to one table; because that is the call we have accepted. I look forward to this journey with all of you, all of you, one Pasadena.

God bless the United States of America and God bless the people of Pasadena, California."
