AN ORDINANCE OF THE CITY OF PASADENA AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF PASADENA ESTABLISHED BY SECTION 17.20.020 OF THE PASADENA MUNICIPAL CODE (CRAFTSMAN HEIGHTS LANDMARK OVERLAY DISTRICT)

The People of the City of Pasadena ordain as follows:
SECTION 1. This ordınance, due to its length and corresponding cost of publıcation will be published by title and summary as permitted by Section 508 of the City Charter. The approved summary of this ordinance is as follows.

## "SUMMARY

This proposed ordinance will amend the official zoning map of the City of Pasadena, and modify the boundaries of certain zoning districts to establish the Craftsman Heights Landmark Overlay District. A map showing these modifications is attached to the full text of the ordinance and is on file in the City Clerk's Office.

Ordinance No. $\qquad$ shall take effect 30 days from its publication."

SECTION 2. The official zoning map of the City of Pasadena as established by Section 17.20 .020 is amended by modifying the boundaries of certain zoning districts established therein as follows:

By reclassifying from the RS-6 (Single-Family Residential) and RM-12, RM-16 and RM-32 (Multı-Famıly Resıdentıal) to RS-6-LD-26 (Single-Family Residentıal, Craftsman Heights Landmark District) and RM-12-LD-26, RM-16-LD-26 and RM-32-LD26 (Multi-Family Residential, Craftsman Heights Landmark District) as shown on the map entitled "Craftsman Heights Landmark District" attached hereto as Exhibit A and incorporated herein by this reference as if fully set forth herein, and on file in the City Clerk's office of the City of Pasadena.

SECTION 3. Notwithstanding any provision of Title 17 to the contrary, all future construction, exterior alterations, relocatıons or demolitions initiated by application for a buildıng permit, land-use entitlement or building plan check on or after the effective date of this ordınance will require a Certificate of Appropriateness prior to the issuance of any building permits according to the guidelines set forth in the Secretary of the Interior's Standards for Rehabilıtatıon and the Illustrated Guıdelınes for Rehabilitatıng Historic Buildings and the "Design Guidelines for Historic Districts" on file in the City Clerk's Office of the City of Pasadena

SECTION 4. The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published by title and summary.

SECTION 5. This ordinance shall take effect 30 days from its publication.
