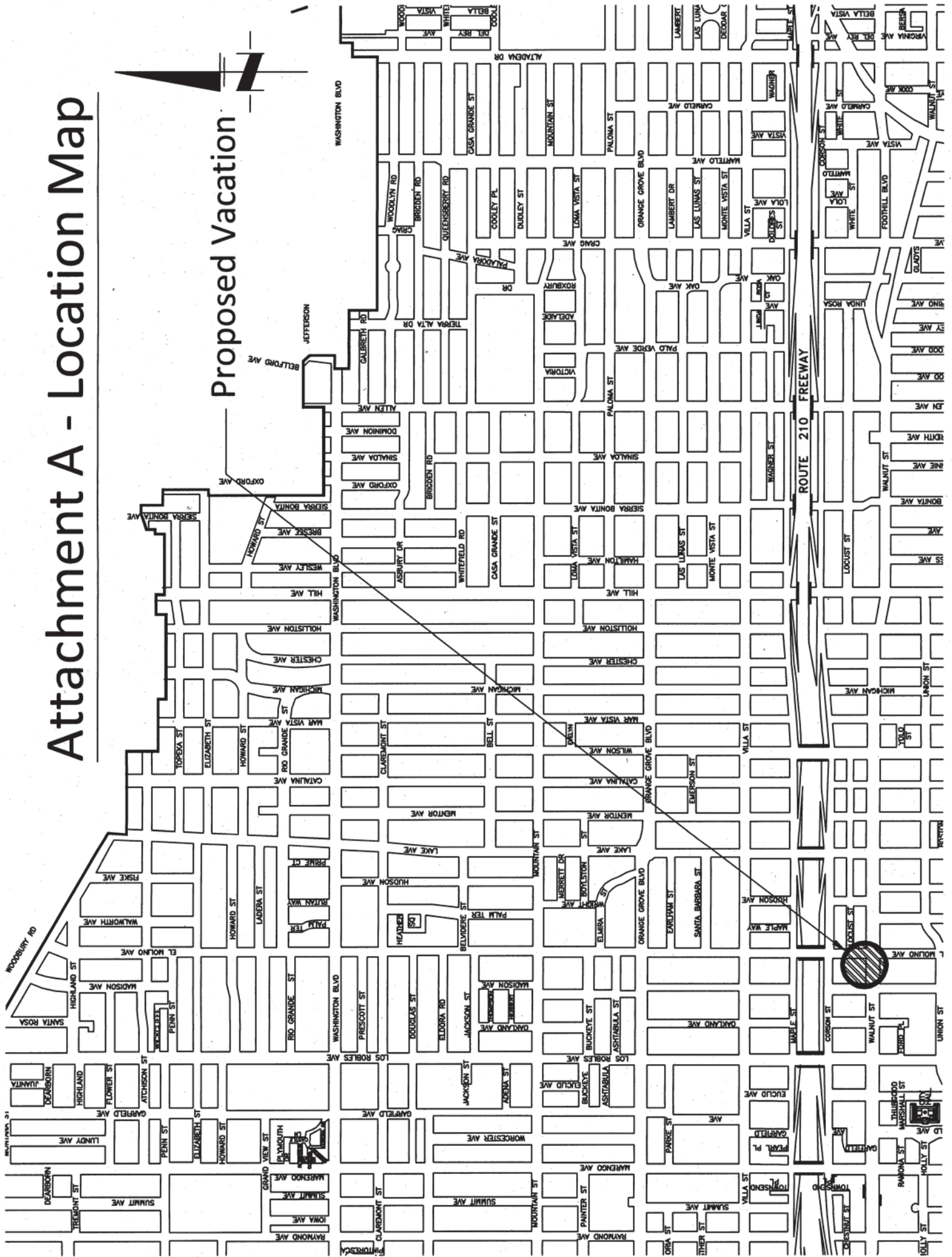


Attachment A - Location Map

GRANT OF EASEMENT (No. 6709)

FOR VALUABLE CONSIDERATION, HARBOR SERVICE STATIONS, INC., a California corporation, hereby grants to the CITY OF PASADENA, a municipal corporation, an easement for street purposes in, over, under and upon the following described property:

A portion of Lot 6 in Block "D" of the San Pasqual Tract, in the City of Pasadena, County of Los Angeles, State of California, as per map recorded in Book 3, page 315 of Miscellaneous Records in the office of the County Recorder of said county, described as follows:

Commencing at the southeast corner of said Lot 6; thence northerly along the southerly prolongation of the existing westerly line of El Molino Avenue (formerly Moline Avenue), 50 feet in width, to a point of intersection with the northerly line of Walnut Street as it formerly existed, 50 feet in width, prior to a final decree of condemnation had in Superior Court, Los Angeles County, Case No. 219347, as recorded in Book 7232, page 202 of Official Records of said County Recorder, said point of intersection being the true point of beginning; thence continuing northerly along said southerly prolongation and along said existing westerly line of El Molino Avenue a distance of 88 feet; thence westerly and parallel to said northerly line of Walnut Street to a line that is parallel with and 15 feet westerly, measured at right angles, from said westerly line of El Molino Avenue; thence southerly along said last mentioned parallel line to the beginning of a tangent curve, concave north-westerly, having a radius of 15 feet, said curve also being tangent to a line that is parallel with and 13 feet northerly, measured at right angles, from said northerly line of Walnut Street; thence southwesterly along said curve to its point of tangency with said last mentioned parallel line; thence westerly along said last mentioned parallel line to a line that is parallel with the said westerly

line of El Molino Avenue and which intersects said northerly line of Walnut Street at a point thereon that is 159 feet westerly of JB the true point of beginning; thence southerly along said last mentioned parallel line to said northerly line of Walnut Street; thence easterly along said northerly line to the true point of beginning.

Except therefrom that portion of said land included within the limits of said above described final decree of condemnation.

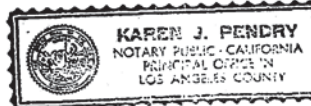
