SUBJECT: OPENING OF PUBLIC HEARING FOR THE FISCAL YEAR 2019 RECOMMENDED OPERATING BUDGET

RECOMMENDATION:

It is recommended that the City Council:

- 1. Open the public hearing for the Fiscal Year 2019 Recommended Operating Budget; and
- Continue this public hearing to each subsequent regular meeting of the City Council at 7:00 p.m. until June 18, 2018 or such other date as the City Council may determine, and at which time the City Council will be asked to close the public hearing and adopt the Fiscal Year 2019 Recommended Operating Budget.

BACKGROUND:

MEETING OF

Section 902 of the City Charter requires that on or before the third Monday in May the City Manager shall submit an annual operating budget. The recommended budget represents the City's financial plan for fiscal year 2019 and furthers the City's mission to deliver exemplary municipal services responsive to our entire community and consistent with the City's history, culture and unique character.

In addition to the City's anticipated operating revenues and expenses, the Recommended Budget included the appropriations for the Fiscal Year 2019-2023 Capital Improvement Plan and the City's affiliated agencies (Rose Bowl Operating Company, Pasadena Center Operating Company, and Pasadena Community Access Corporation).

Attachment A provides a summary of citywide fiscal year 2019 recommended appropriations by department and affiliated agencies. The corresponding budget information has been made available for public review at City facilities and on the City's website.
