Dear Mayor, City Council, and Planning Department,

While the board of the Madison Heights Neighborhood Association (MHNA) appreciates the efforts of the Arts and Culture Commission's review and recommendations to the City Council to approve artist Alice Aycock's concept and art plan for the Glenarm Power Plant, we believe there have been some significant oversights with the process and plan.

The Capital Public Art Program Guidelines provides for the assembly of a group of stakeholders to create a vision for the project that typically draws representatives from residential/neighborhood associations, but in this case, MHNA was omitted from the group because the Glenarm Power Plant has been defined as a "gateway" project. We disagree that this is only a gateway project, because the illumination will be reflected on our neighborhood and the art will be visible from a portion of our neighborhood.

MHNA questions why those from Blair High School and ArtCenter were included due to their proximity to the project site, while MHNA, which is the same distance from the proposed project as Blair High School, was not. As you are probably well aware, MHNA is filled with artists and teachers of art, including renowned Pasadena artists Kenton and Tess Nelson, who would have made valuable contributions to the conversation. More troublingly, none of our residents have reported even knowing about the art until it was covered by *Pasadena Now* on Tuesday, March 14th, even though it is only a block from our boundaries.

In addition, we understand ArtCenter would like to have a massive electronic billboard on the corner of Arroyo and Glenarm just across from the planned public art project. We do not believe our city has contemplated having both illuminated pieces on the same corner, which will produce safety and light issues. This busy intersection involves both a freeway terminus and a light rail crossing. Many pedestrians and cyclists cross that intersection as well, including students from three nearby schools, and the last thing we need there are giant, illuminated attention-grabbers that will significantly distract drivers.

Last, the project goals repeatedly state how this project should connect and enhance the neighborhood and how this public art should reinforce the identity of those neighborhoods. Yet there are zero mentions of neighborhoods in any of the artist-proposed concepts. Indeed, nothing about this proposed public art reflects anything about Pasadena. While we enthusiastically support public art, we further feel that since it is public art, the City should seek work that is somewhat less avant-garde and polarizing, and instead approve a project that's likely to be at least somewhat more widely appealing. Excellent examples include "Language of the Birds" in San Francisco, the "CLoud Gate" in Chicago, "Make Way for Ducklings" in Boston, "Urban Light" at LACMA, the fun "Luci d'Artista" neon art project in Turin, Italy, etc.

The people living within MHNA are in a difficult position because our neighborhood might suffer from light pollution, increased traffic accidents, and, frankly, a Vegas-style gateway only a block from our homes. We

ask the City Council to reconsider, and to allow our neighborhood time to meet with the artists, have input, and voice our concerns before moving forward financially. We also ask the Council to consider pausing approval of the commission's findings until the planning and decision regarding ArtCenter's billboard is complete.

As MHNA creates a more engaged community through social media and town hall meetings, it is our goal to work together with the City Council and staff to create communities that fit all of our needs.
