Armando Herman, residence not stated, spoke on the difficulties involved in applying for a California Driver's license.

Kris Ockershauser, and Vincent De Stafano, Coalition for Increased Oversight of Pasadena Police (CICOPP), submitted literature and spoke on AB 392: California Act to Save Lives.

Councilmember Kennedy asked staff to provide an update on AB 392 to the Public Safety Committee.

Christopher Sutton, representing several tenants residing in California Department of Transportation (Caltrans) properties, reiterated his request for the City to pursue code enforcement actions against dilapidated structures located in Pasadena that are owned by Caltrans.

CONTRACT AWARD TO INTERNATIONAL LINE BUILDER'S, INC., FOR TRAFFIC SIGNAL INDICATION SAFETY IMPROVEMENTS FOR AN AMOUNT NOT-TO-EXCEED \$260,000

Recommendation:

- (1) Find the project proposed in the agenda report to be categorically exempt under the California Environmental Quality Act (CEQA) State Guidelines in accordance with Title 14, Chapter 3, Article 19, Section 15301, Class 1, minor alterations of existing public facilities involving negligible or no expansion of use beyond that previously existing at the time of the lead agency's determination, and find that there are no features that distinguish this project from others in the exempt class, and therefore, there are no unusual circumstances; and
- (2) Accept the bid dated June 12, 2019, submitted by International Line Builder's Inc., in response to the project plans and specifications for Traffic Signal Indication Safety Improvements, reject all other bids received, and authorize the City Manager to enter into a contract not-to-exceed \$260,000, which includes the base contract amount of \$226,172 and a contingency of \$33,828 to provide for any necessary change orders. (Contract No. 31510)

Ara Maloyan, Director of Public Works, responded to questions related to the scope of work included in the contract agreement.

Vice Mayor Hampton requested that staff repair the crosswalk activation button on Lincoln Avenue and West Montana Street.

Following discussion, it was moved by Vice Mayor Hampton, seconded by Councilmember McAustin, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

CONTRACT AWARD TO SELECT PATROL AGENCY, INC., TO PROVIDE SECURITY AND COURIER SERVICES FOR AN AMOUNT NOT-TO-EXCEED \$4,885,290

Recommendation:

(1) Find that this action is exempt under the California Environmental Quality Act (CEQA) in accordance with Section 15061(b)(3), the General Rule that CEQA only applies to projects that may have a significant effect on the environment; and

(2) Authorize the City Manager to enter into a contract, based on a competitive selection process pursuant to Pasadena Municipal Code Section 4.08.047, with Select Patrol Agency, Inc., (Select Patrol) for security services for three years for an amount not-to-exceed \$2,906,633 with the option of two one-year extensions, subject to the approval of the City Manager, for a maximum contract length of five years and a total contract amount of \$4,885,290. (Contract No. 31507)

Ara Maloyan, Director of Public Works, and Randy Rich, City Service Worker, responded to questions related to the scope of work detailed in the proposed contract award.

Vice Mayor Hampton suggested that the security firm's scope of work include the patrolling of City parks, as well as ensuring the closing and locking parks, restrooms, and gates.

City Manager Mermell responded that he would meet with Mr. Maloyan and Police Chief Perez, to discuss issues related to loitering in public parks after operational hours.

Vice Mayor Hampton and Councilmember Wilson requested that in the future, the staff report include an itemized list of costs and scope of work related to a contract approval with a substantial amount of capital.

Following discussion, it was moved by Vice Mayor Hampton, seconded by Councilmember Masuda, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

CONTINUED PUBLIC HEARING: CALL FOR REVIEW OF THE DESIGN COMMISSION'S DECISION ON AN APPLICATION FOR CONSOLIDATED DESIGN REVIEW FOR A NEW 112,205-SQUARE-FOOT, 5-STORY MEDICAL OFFICE AND RETAIL BUILDING AT 550-566 EAST COLORADO BOULEVARD Recommendation: It is recommended that the City Council continue the public hearing to August 19, 2019 at 7:00 p.m.

It was moved by Councilmember Masuda, seconded by Vice Mayor Hampton, to continue the public hearing to August 19, 2019, at 7:00 p.m. (Motion unanimously carried) (Absent: None)

PUBLIC HEARING: DESIGNATION OF THE HOUSE AT 280 CALIFORNIA TERRACE AS A LANDMARK Recommendation:

- (1) Find that the designation of a historic resource is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15308 Class 8 of the CEQA State Guidelines pertaining to Actions by Regulatory Agencies for Protection of the Environment and there are no features that distinguish this project from others in the exempt class, and, therefore, there are no unusual circumstances;
- (2) Find that main residence, attached garage, arbors, dendriform sculpture, pool and hardscape adjacent to the house

at 280 California Terrace meet landmark designation criterion C in Pasadena Municipal Code (P.M.C.) Section 17.62.040(C)(2)(c) because they embody the distinctive characteristics of a locally significant property type, architectural style and period. The building and accessory structures are locally significant, intact example of a single-family residence property type built in the Mid-Century Modern style, designed by locally significant architect Thornton Ladd, and retains integrity;

(3) Adopt a resolution approving a Declaration of Landmark Designation for 280 California Terrace, Pasadena, California;

(4) Authorize the Mayor to execute the Declaration of Landmark Designation for 280 California Terrace, Pasadena, California; and

(5) Direct the City Clerk to record the declaration with the Los Angeles County Recorder. (Resolution No. 9730)

Recommendation of the Historic Preservation Commission: At its regular meeting of June 4, 2019, the Historic Preservation Commission recommended that the City Council approve the designation of the house and accessory structure at 280 California Terrace as a Landmark under Criterion "C" of PMC Section 17.62.040

The City Clerk reported that 155 copies of the notice were mailed and 23 copies of the notice were posted on June 28, 2019; and no correspondence was received by the City Clerk's office regarding the item.

David Reyes, Director of Planning and Community Development, provided introductory comments, and Leon White, Principal Planner, provided a PowerPoint presentation on the item.

It was moved by Councilmember Madison, seconded by Councilmember Gordo, to close the public hearing. (Motion unanimously carried) (Absent: None)

Following a brief discussion, it was moved by Councilmember Madison, seconded by Councilmember Gordo, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

RECOMMENDATIONS FROM OFFICERS AND DEPARTMENTS

PROPOSED POLICY REGARDING PUBLIC BENEFIT PAYMENTS RELATED TO DEVELOPMENT AGREEMENTS WITH TAX-EXEMPT INSTITUTIONS Recommendation:

(1) Find that the actions proposed in the agenda report are exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA State Guidelines Section 15061(b)(3) (Common Sense Exemption); and

(2) Adopt a policy whereby Development Agreements between tax-exempt institutions and the City of Pasadena include a Public Benefit Payment made by the institution.

City Manager Mermell provided introductory comments and David Reyes, Director of Planning and Community Development, provided a PowerPoint presentation on the item and, jointly responded to questions.

Councilmember Madison expressed concerns with the staff recommendation, stating that staff was asked to return to the City Council with a policy providing the specific details, standards and criteria related to the Payments in Lieu of Taxes (PILOT). He expressed concerns with the controversial unintended consequences related to PILOT's, and the impacts this will have on non-profit organizations in the City, citing the ArtCenter College of Design (ArtCenter) as an example. He noted the problematic nature of imposing "taxes" on non-profit organizations, when legally they are tax exempt. Councilmember Madison spoke in opposition to the staff recommendation; and asked staff to provide information on the number of municipalities in California that utilize similar "PILOT" programs.

Councilmember McAustin spoke in favor of the staff recommendation, which is designed to collect PILOT when a Master Plan and Development Agreement are proposed by a non-profit institution, which she believes is reasonable if such a proposed project will have an intensification of use at the site, which will result in an impact on City resources.

Councilmember Wilson expressed concerns that the Public Benefit Payment included with the ArtCenter's Development Agreement, noting that it appears to penalize the ArtCenter for providing dormitories, or affordable units, in the City; and spoke on the need for clear policy for the proposed PILOT program.

Councilmember Gordo spoke on the need to provide clarity with the proposed PILOT program, specifically on how staff will apply this to Master Plans and Develop Agreements moving forward. He spoke on the inequity that such intensifications of use has on City residents by straining existing levels of service. He also spoke in favor of the staff recommendation, including a PILOT as part of a Master Plan and Development Agreement. He asked staff to provide detailed policy guidelines to ensure clarity on what data is used to determine the PILOT fees, and the policy must include a case by case review, as well as a comparative analysis on the benefits and additional burdens proposed by the Master

Plan and Development Agreement, with staff to return to the City Council with an update.

The Mayor spoke in support of the staff recommendation, and reassured the public that the staff recommendation is not a tax on non-profits, but rather a defined benefit to the City to cover increased service costs, in return for a significant benefit to a non-profit institution.

Ken Hargreaves, External Relations Officer with California Institute of Technology (Caltech), expressed concerns with the staff recommendation.

Following discussion, it was moved by Councilmember McAustin, seconded by Councilmember Gordo, to approve the staff recommendation, amended to direct staff to return to the City Council by September 2019 with a specific policy and guidelines applicable to any future public benefit payments to be collected for Master Plans and Development Agreements proposed by taxexempt institutions:

COUNCIL COMMENTS

Vice Mayor Hampton requested an update on both the cannabis permitting process and Caltrans properties. He spoke on the need for the Pasadena Unified School District to ensure that school sites are better maintained, and suggested that the City's Code Compliance staff enforce the maintenance of those properties.

Michele Beal Bagneris, City Attorney/City Prosecutor, responded that as a general rule, public school property that is used for school purposes is preempted by State codes. City Manager Mermell stated that he will be meeting the PUSD's Superintendent and he will discuss the maintenance concerns.

Councilmember Gordo requested an update on the City's cannabis permitting process to ensure the City Council is informed and has a better understanding on the process.

In response to Vice Mayor Hampton and Councilmember Gordo's inquiries regarding the cannabis permitting process, City Manager Mermell stated he anticipated that there will be a closed session discussion on this issue in the next few weeks, agreed to provide

an update in the weekly newsletter, and noted that information on the process is available on the City's website.

Councilmember Kennedy thanked staff and all individuals who participated in the City Council District 3 Community Meeting held on Wednesday, July 10, 2019 at the Heritage Square Senior Apartments in the Community Room.

Councilmembers Kennedy and Gordo reminded District 3 and 5 residents that a neighborhood walk is scheduled for Saturday, July 20, 2019.
