Project Description: The Salvation Army is proposing to develop a four story new construction project to advance its charitable, tax exempt mission. The first floor will consist of a social services center for provision of direct food and material and other assistance to low-income and homeless people in the community. The second through fourth floors will accommodate 65 supportive housing apartments, and one staff apartment, in which very low income homeless people will be permanently housed and receive rent subsidy and supportive services.

That limited partnership has not yet been formed or entered into, but it will provide that an entity of The Salvation Army own .01% of the project and an investor limited partner own 99.99% of the project. The investor limited partner has not yet been selected but will most likely be an entity of Enterprise Community Partners or Enterprise Community Investments.
