RESOLUTION OF THE CITY OF PASADENA APPROVING THE APPLICATION FOR GRANT FUNDS FROM THE LOS ANGELES COUNTY REGIONAL PARK AND OPEN SPACE DISTRICT FOR 5th SUPERVISORIAL DISTRICT PROP A FUNDING FOR ONE ARROYO DEMONSTRATION PROJECTS

WHEREAS, the people of the County of Los Angeles on November 3, 1992, and on November 5, 1996 enacted Los Angeles County Proposition A, Safe Neighborhood Parks, Gang Prevention, Tree-Planting, Senior and Youth Recreation, Beach and Wildlife Protection (the Propositions), which among other uses, provides funds to public agencies and nonprofit organizations in the County for the purpose of acquiring and/or developing facilities and open space for public recreation; and

WHEREAS, the Propositions also created the Los Angeles County Regional Park and Open Space District (the District) to administer said funds; and

WHEREAS, the District has set forth the necessary procedures governing application for grant funds under the Propositions, and

WHEREAS, the District's procedures require the City of Pasadena to certify, by resolution, the approval of the application before submission of said application(s) to the District; and

WHEREAS, said application contains assurances that the City of Pasadena must comply with; and

WHEREAS, the City of Pasadena certifies, through this resolution, that the application is approved for submission to the District; and

WHEREAS, the City of Pasadena will enter into an Agreement with the District to provide funds for development of the One Arroyo Demonstration Projects (the projects); and

WHEREAS, the District's procedures require the adoption of a Youth Employment Plan for development projects by the governing body of the agency.

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY OF PASADENA HEREBY:

- 1. Approves the filing of an application with the Los Angeles County Regional Park and Open Space District for Funds for the projects; and
- Certifies that the City of Pasadena understands the assurances and certification in the application form; and
- Certifies that the City of Pasadena has, or will have, sufficient funds to operate and maintain the projects in perpetuity; and
- 4. Certifies that the City of Pasadena will sign and return, within 30 days, both copies of the project agreement sent by the District for authorizing signature; and
- Agrees to develop and submit to the County a Youth Employment Plan for the projects to provide meaningful youth opportunities during the construction phase of the projects and approve said plan prior to requesting payment of grant funds; and
- Appoints the City Manager, or designee, to conduct all negotiations, and to execute and submit all documents including, but not limited to, applications, agreements, amendments, payment requests and so forth, which may be necessary for the completion of the aforementioned project.
