Recommendation:

- (1) Find that the proposed action is not a project subject to the California Environmental Quality Act ("CEQA") pursuant to Section 21065 of CEQA and Sections 15060(c)(2), 15060(c)(3), and 15378 of the State CEQA Guidelines, and as such, no environmental document pursuant to CEQA is required for the project; and

MODIFICATIONS TO THE TENANT PROTECTION ORDINANCE PASADENA MUNICIPAL CODE CHAPTER 9.75

Recommendation:

- (1) Find that the recommended action is exempt from the California Environmental Quality Act (“CEQA”) pursuant to State CEQA Guidelines per Section 15061(b)(3), the General Rule that CEQA only applies to projects that may have an effect on the environment;
- (2) Approve the proposed modifications to the Tenant Protection Ordinance as contained in the agenda report; and
- (3) Direct the City Attorney to prepare an amendment to the Tenant Protection Ordinance (Chapter 9.75, Pasadena Municipal Code) in accordance with the proposed modifications contained in the agenda report, and return within 60 days.

Bill Huang, Director of Housing and Career Services, provided introductory comments, and Jim Wong, Senior Project Manager, presented a PowerPoint presentation on the item; and responded to questions.

Councilmember McAustin requested that staff identify the number of apartments in the City with five units or less, to understand the level of impacts to small apartment owners that may occur should the Tenant Protection Ordinance (TPO) be expanded.

Councilmember Madison expressed concerns with the policy that would saddle the individuals who are providing housing with all of the burden.

Councilmember Gordo expressed concerns with the unintended consequences of expanding the TPO; and stated that the staff recommendation does not include any preventative measures to address current property owners from evicting renters prior to placing rental units on the market.

Michele Beal Bagneris, City Attorney/City Prosecutor, responded to questions related to the concept of public generally exception, and conflicts of interest.

Councilmember Hampton spoke in favor of the staff recommendation, but suggested a change to Modification No. 1 Expand TPO for Change in Property Ownership, to read, "A rent

increase will be considered to be large if it exceeds Consumer Price Index (CPI) + 5% within an 18-month period." He spoke on the need for additional information to fully understand the impacts of the modification, and requested that staff return to the City Council in 12 months with data on rent increases throughout the City.

The City Council thanked staff for their diligent work on the matter, and for working with the public, including property owners and apartment renters.

Councilmember Gordo spoke in support of City staff gathering additional data; and requested that staff also provide information to the following questions:

- Number of properties that the City has subsidized since calendar year 2000;
- How much of the funds have been repaid;
- How many of those property owners increased rents on a yearly basis; and
- Number of outstanding subsidized loans.

Councilmember Gordo expressed concerns with the City subsidizing the Groves property located at 772 Mountain Street for a non-profit organization, who then sold the property to a different non-profit organization that raised the rents for the units. He also spoke on the need for additional discussion on social equity, and reiterated his request for a City Council discussion on the issue of over-concentration of affordable housing and the need to disperse affordable units throughout the City.

Councilmember Madison spoke on the need to provide affordable housing for seniors, stated that he is in support of the staff recommendation, however, he requested that staff provide a comprehensive response to the concerns raised by the public.

Councilmember McAustin, while speaking in favor of the staff recommendation, noted that it was the City Council that gave staff direction to recommend limited modifications to the TPO; and spoke on the need for additional rental units to meet the needs of the community. She requested that staff provide information on the Planning Commission's scope of work related to housing issues, including information on the City's affordable housing stock.

The Mayor commended the staff on addressing the clear, significant inequitable failures of the current TPO, which he believes the proposed staff recommendation addresses.
