Hello,

My name is Reo Glancey, and I am a Pasadena resident of Council District 7. I call upon you to amend the City Charter to create a civilian-based police oversight commission consisting of an independent auditor and representative community members who are granted subpoena and binding disciplinary powers. Please do not accept the proposed structure for this Commission.

The current Public Safety Committee proposal is unacceptable, as it grants no subpoena or binding disciplinary powers to a commission of community members and an Independent Auditor. The proposed oversight team would only review information voluntarily provided by the police department and make recommendations that the Police Chief and City Manager may or may not choose to follow. These bodies must be disentangled. The Independent Police Auditor should report to the City Council in order to avoid a conflict of interest as the Police Chief reports to the City Manager. The proposed model doesn't provide enough independent oversight, and it doesn't come from the voices in our community that most suffer police violence. The recommendation calling for only 3 out of the 13 commission appointments to come from the community at large is insulting and cynical. Such make-up could easily turn the commission into a political body and not a representative one.

Effective oversight has the potential to hold the Pasadena Police Department accountable, aid in the appropriate disciplining of officers who violate laws, increase transparency, increase public safety, and build trust. The current Public Safety Committee proposal is unacceptable as it does not grant any meaningful power to our communities, which Council members have been elected to serve. Our community deserves better, and particularly our neighbors of color deserve better. In this historical moment, our elected officials must do everything necessary to eradicate police injustice. Community regulated checks and balances of those who are sworn to serve and protect our community should be a self-evident need, and now is the time for true course correction. Please vote to amend the City Charter.
