Matt Hawkesworth, Director of Finance, responded to questions related to reporting on the Foothill Workforce Investment Board funding, revenues and grant funds; and the Pasadena Center Operating Company's (PCOC) negative net position and the value of the building. City Manager Mermell stated that he will be meeting with Management staff, including the Economic Development Manager to discuss the City's federal funding levels.

Member Wilson stated that the Rose Bowl Operating Company's (RBOC) financial report included an excellent summary of events that he found to be very informative and thanked staff for the information.

Chair Tornek, Chair of the Finance Committee, summarized the Committee's discussion on the reports, and recommended for all individuals who are interested in the City's financial condition to review the Comprehensive Annual Financial Reports, which are available on the City's website. Member Madison also recommended the City's Budget in Brief, which includes a summary of the City's revenues, costs and fund balances.

Member McAustin spoke on the UCLA Athletic Department's reported financial deficit, which may fiscally impact the RBOC.

Member Kennedy suggested inviting Douglas Kranwinkle, President of the RBOC, to present to the City Council to report on the RBOC's vision for the future and their finances.

Following discussion, it was moved by Member Wilson, seconded by Vice Chair Hampton, to approve the staff recommendation. (Motion unanimously carried) (Absent: Member Gordo)
