<u>Temporary Cap on Commission</u> <u>Fees Charged by Third Party</u> <u>Delivery Service Providers</u>





- Third-party delivery services charge restaurants commission fees that can reach up to 30 percent or more order, including delivery, subscription and processing fees.
- Core components of third-party delivery fees can include:
  - > Fees/Commissions paid by a restaurant to the service:
    - Menu Fees, Commission Fees, Pick-Up/Takeout Commission, Marketing Fee
  - > Fees paid by the consumer to the service:
    - Service Fee, Delivery Fee, Gratuity, Taxes

#### Proposed Los Angeles County Ordinance (Food Delivery Platforms):

**Fee Limits.** It shall be unlawful for a third-party delivery service to charge a covered establishment:

- a. Any combination of fees, commissions or costs that total more than 20 percent of the Purchase Price of each Online Order. Fees, commissions or costs includes a Delivery Fee.
- b. A delivery fee that totals more than 15 percent of the purchase price of an online order;
- c. Any fee, commission, or cost other than as permitted in subdivisions (a) and (b), above.

**Reporting of Fees.** The third-party delivery service shall disclose to the customer an accurate, clearly identified, and itemized cost breakdown of each transaction, including, but not limited to, the following:

- a. The purchase price of the food and beverages at the cost listed on the covered establishment's menu;
- b. Each and every fee, commission, or cost charged to the covered establishment, including any Delivery Fee.
- c. Each and every fee, commission, or cost charged to the customer by the third-party delivery service; and
- d. Any tip or gratuity that will be paid to the person delivering the food or beverages.
- e. None of the fees, commissions, or costs in subdivisions (a) through (d) above, may be combined together.

**Protection of Gratuities**. It shall be unlawful for a third-party delivery service to reduce the compensation, including any tip or gratuity, paid to any workers as a result of the prohibitions in this Sixth Supplement. Any tip or gratuity shall be paid by the third-party delivery service, in its entirety, to the person delivering the food or beverages.

- Survey Emailed to All Retail Food Establishments in Pasadena
  - > 66 Respondents
  - > 89% use third-party delivery services
  - > Average commission ranged between 16 -31%
    - 25-30% for delivery orders
    - 10-17% for customer pick-up orders
  - > 92% of respondents support a temporary cap on commissions paid to third-party delivery services

- Direct City Manager to pursue a local emergency supplement to place a temporary cap on commission fees charged by third-party delivery services to retail food establishments in Pasadena
  - > To remain consistent with neighboring cities and to make it easier for third party delivery services to implement said cap in the Los Angeles region, it is recommended that Council direct the city manager to place a cap of all fees, commissions or costs that total no more than 20 percent of the Purchase Price of each online order. Fees, Commissions, or Costs includes a delivery fee.
  - > As part of that 20 percent cap, a delivery fee should total no more than 15 percent of the purchase price of an online order.
  - > Recommend transparency requirements, considerations of gratuities and a sunset clause of 90 days following a Health Officer Order is issued to allow dine-in service, without limitation.
