SUBJECT: AUTHORIZATION TO ENTER INTO A CONTRACT WITH DIXON RESOURCES UNLIMITED FOR CONSULTING SERVICES FOR THE DEVELOPMENT OF A PARKING STRATEGIC PLAN

RECOMMENDATION:

It is recommended that the City Council:

- Find that this action is exempt under the California Environmental Quality Act (CEQA) in accordance with Section 15061(b)(3), the General Rule that CEQA only applies to projects that may have an effect on the environment;
- Authorize the City Manager to enter into a contract, as a result of a competitive selection process pursuant to Pasadena Municipal Code Section 4.08.047, with Dixon Resources Unlimited for the creation of a Parking Strategic Plan for an amount not to exceed \$131,747;
- 3. Amend the Department of Transportation's Fiscal Year 2020 Operating Budget by appropriating \$101,183 from Fund 407 Off-Street Parking Facilities unappropriated fund balance to the various garage organizations in Fund 407 as listed in the Fiscal Impact section of this Agenda Report. The remaining \$30,564 will be offset by savings in the existing Fiscal Year 2020 budgeted appropriations in the various parking funds as listed in the Fiscal Impact section.

BACKGROUND:

The City of Pasadena's Parking Division oversees nine (9) parking garages with 6,175 spaces, three surface lots that contain 967 spaces, and an on-street parking system that includes approximately 1,250 metered spaces and 13,000 non-metered parking spaces. Additionally, the Parking Division is responsible for parking enforcement activities that include enforcement activities in metered and time limited parking spaces, and for overnight parking between 2:00 a.m. and 6:00 a.m. citywide. The Parking Division oversees annual revenues of approximately \$26.5M.

Since 2014, the City's Parking program has been the subject of several audits, each resulting in various recommendations for operations. Some of these recommendations have caused DOT staff to engage in deeper internal reviews. In order to provide a cohesive approach to comply with audit recommendations and best practices, Dixon Resources Unlimited will review all aspects of the City's Parking operation, including, but not limited to: off-street garage and parking lot operations, on-street parking operations, the use of technology, rates and rate modeling and City owned property disposition.

DOT staff anticipates returning to City Council once the plan is completed to provide recommendations as to how the City should proceed with its parking program.

Competitive Selection

The Department of Transportation prepared a Request for Proposals (RFP) for the subject project. The RFP was released on October 17, 2019 with a due date of November 27, 2019.

Six proposals were received from the following vendors:

- Dixon Resources Unlimited; San Diego, CA
- General Technologies & Solutions; Los Angeles, CA
- Nelson Nygaard; Los Angeles, CA
- Transpo Group; Kirkland, WA
- Walker Consultants; Tampa, FL

The proposals were reviewed and evaluated by a committee of representatives from the City of Pasadena and the Los Angeles County Metropolitan Transportation Authority (Metro). The committee used the following criteria for evaluation, as was provided as part of the RFP:

The proposal by Dixon Resources Unlimited was rated highest on the basis of their comprehensive proposed solution, their extensive experience with similar projects in the State of California and the overall value of their proposal with consideration given to their cost proposal in comparison with the other proposals (Attachment A).

In 2015, DOT contracted with Dixon Resources Unlimited in the amount of \$11,350 to complete an assessment of meter operations and collections procedures with recommendations for best practices. More recently, Dixon Resources Unlimited have completed similar program reviews for the Cities of San Leandro, Paso Robles, Seal Beach and Laguna Beach. They have also successfully completed projects in Beverly Hills, Los Angeles, Newport Beach and San Jose. They are a woman-owned, California certified Disadvantaged Business Enterprise Program and a California Certified Small Business.

COUNCIL POLICY CONSIDERATION:

This project is consistent with the City Council's goal to improve, maintain and enhance public facilities and infrastructure. It also supports and promotes the quality of life and the local economy.

ENVIRONMENTAL ANALYSIS:

The project has been reviewed for compliance with the California Environmental Quality Act (CEQA) and is exempt per Section 15061 (b) (3). The project is covered by the general rule that CEQA only applies to projects that have the potential for causing a significant effect on the environment. The contract with Dixon Resources Unlimited will not result in any significant effect on the environment.

FISCAL IMPACT:

The total cost of this action is \$131,747.

The following table shows the breakout of funding for this action. There is saving in various parking funds to accommodate \$30,564 of the total \$131,747 however, the Department of Transportation recommends appropriating an additional \$101,183 in FY 2020 project costs from projected year-end unappropriated fund balance in both On-Street and Off-Street Parking Facilities Fund to the following accounts:
