On order of the Mayor, the regular meeting was called to order at 6:38 p.m. The pledge of allegiance was led by Councilmember Masuda.

#### ADOPTION OF A RESOLUTION RATIFYING THE HEALTH **OFFICER'S** DECLARATION OF LOCAL HEALTH **EMERGENCY IN RESPONSE TO COVID-19**

Recommendation: It is recommended that the City Council: (1) Find that the proposed action is exempt from the California Environmental Quality Act (CEQA) pursuant to state CEQA Guidelines Section 15061(b)(3) (Common Sense Exemption); and (2) Adopt a resolution ratifying the March 4, 2020, Health Officer Declaration of a local health emergency in response to COVID-19. (Resolution No. 9767)

City Manager Mermell provided introductory comments, and Dr. Ying Ying Goh, MD, Director of Public Health, presented a PowerPoint presentation on the item, with both responding to questions. Jennifer Waldron, Disaster Coordinator, Leonard De La Cruz, Director of Infection Prevention and Control, Dr. Kimberly Shriner, and Dr. David Mann, all with Huntington Memorial Hospital (HMH), jointly, presented a PowerPoint presentation on HMH emergency plans in place to accommodate a surge of patients, coordinating efforts with other medical organizations, and patient management, with all responding to guestions. Lisa Derderian, Public Information Officer, responded to guestions related to information on public announcements.

Vice Mayor Hampton asked staff to pay extra attention to the Senior Center to avoid exposing seniors to Covid-19; and include on the City's website advisory bulletins/warnings related to Covid-19 for anyone interested in attending Art Night. He stated the following for the record, "A lot of major corporations have actually cancelled events that have gone over 100 people because of this [Covid-19 virus], and until there is some sort of calm...eventually there will be a calm. I'm 100% of that. I think with your data with the flu virus and the death toll...I think as more people are educated about this I think the calm will eventually come, but until that calm comes, we need to make sure we are protecting everyone, and also protecting people from the hysteria that is going along with..."

Councilmember Gordo suggested that staff review mutual aid agreements with ambulance agencies, Los Angeles County Sheriff's Department, and others to ensure the Covid-19 emergency is covered as part of those agreements.

Councilmember Wilson requested that staff utilize all forms of communication to ensure that the community is informed about issues related to the Covid-19 virus to avoid causing panic.

Councilmember Kennedy suggested that staff work with KPAS and KPCC to utilize subtitles in Spanish and Chinese to distribute information on Covid-19 to the community, and to distribute by United States Postal Service for individuals who solely rely on mail for information. He also suggested that staff research Vietnam's actions that have resulted in 100% survival rate of all 16 cases of Covid-19 virus.

Following discussion, it was moved by Vice Mayor Hampton, seconded by Councilmember Wilson, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

PUBLIC COMMENT Pastor Burnes, Pasadena resident, expressed concerns regarding the health and safety for individuals at Union Station Homeless Services Center, noting such issues as the elevator not being in service for months; and the Parsons Project which he argued needs additional City oversight as it is not adhering to the local hiring requirements, and suggested staff host a local job fair to help ensure the project meets the agreed upon local hiring goals.

> Vice Mayor Hampton asked staff to provide information on inspections completed at Union Station, and suggested additional inspections be scheduled to ensure that safe conditions are maintained for those visiting the Center.

City Manager Mermell stated that representatives from the Parson Project provided an update on a job fair they hosted, including over 100 attendees, which resulted in the hiring of several individuals to work on the project. He and Councilmember Kennedy will be meeting with the project's team to discuss local hiring efforts; and an update will be forthcoming to the City Council.

Jane Panangaden, representing Pasadena Tenants Union, distributed information and spoke on the need to amend the City's Tenant Protection Ordinance to address the just cause eviction renovation loophole to provide additional protection.

In response to Vice Mayor Hampton's inquiry, City Manager Mermell stated that he would work with the City Attorney to assess the information provided by the public speaker. Councilmembers Kennedy and Gordo requested that staff work as quickly as possible on the reported loophole to determine its veracity and ensure that the City addresses it in a timely fashion. Councilmembers McAustin, Wilson, and Masuda requested that staff also review protective actions for tenants who may be adversely affected by Covid-19, and determine if the City can levy penalties against violations of the City's protections.

Albina Kamara, Pasadena resident, requested assistance for her and tenants at 230 East California Boulevard, who are being evicted by the "just cause" renovation loophole present in the state legislation.

In response to Councilmember Kennedy's inquiry related to providing assistance to Ms. Kamara, Mayor Tornek stated that staff will contact Ms. Kamara.

Councilmember Gordo and Mayor Tornek asked staff to review legislation on how the City defines and qualifies "substantial renovation," and determine if landlords are complying with the legislation.

The following individuals, expressed concerns and provided comments related to the reassignment of Fire Chief Bertral Washington.

David L. Washington, Las Vegas resident Addington Stewart, International Association of Black Professional Fire Firefighters Armando Herman, residence not stated, provided comment.

<u>CONTINUED PUBLIC HEARING</u>: APPEAL OF BOARD OF ZONING APPEAL'S DECISION ON REVOCATION OF CONDITIONAL USE PERMIT NO. 5535 LOCATED AT 300 W. GREEN STREET, 100-248 S. ORANGE GROVE BOULEVARD, AND 363 W. DEL MAR BOULEVARD

**<u>Recommendation</u>**: It is recommended that the City Council conduct a quasi-

judicial appeal hearing and take the following action:

(1) Adopt the Environmental Determination that the project is exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (CEQA) (Public Resources Code Section 21080(b)(9); Administrative Code, Title 14, Chapter 3, Section 15321, Class 21, Enforcement Actions by Regulatory Agencies), and there are no features that distinguish this project from others in the exempt class; therefore, there are no unusual circumstances. Section 15321 exempts actions by regulatory agencies to enforce or revoke a lease, permit, license, certificate, or other entitlement for use issued, adopted, or

prescribed by the regulatory agency or enforcement of a law, general rule, standard, or objective, administered by the regulatory agency; and

(2) Uphold the Board of Zoning Appeal's decision and approve Revocation of Conditional Use Permit No. 5535, subject to the findings in Attachment A of the agenda report.

The City Clerk reported that 281 copies of the notice were mailed and 69 copies of the notice were posted on January 27, 2020; and that 11 letters in support, 1 letter in opposition of the Revocation of Condition Use Permit (CUP) No. 5535, were received by the City Clerk's Office, which were distributed to the City Council, posted online, and made part of the public hearing record.

David Reyes, Director of Planning and Community Development provided introductory comments, Luis Rocha, Acting Zoning Administrator, presented a PowerPoint presentation on the item; with both responding to questions.

Michael Shonafelt, (representing the applicant) City Ventures, spoke in opposition to the Revocation of CUP No. 5535, and responded to questions.

The following individuals spoke in favor of the Board of Zoning Appeal's decision and approval of Revocation of CUP No. 5535:

Following discussion, it was moved by Councilmember Madison, seconded by Councilmember McAustin, to close the public hearing. (Motion unanimously carried) (Absent: Councilmember Kennedy)

Councilmember Madison spoke in favor of the staff recommendation, noting the Board of Zoning Appeal's (BOZA) unanimous decision to approve the revocation.

Councilmember Gordo spoke on CUP No. 5535 and the changed circumstances; and spoke in favor of the staff recommendation.

In response to the Mayor's inquiries related to the provision contained in Section 17.78.090 (Permit Revocation or Modification) of the City's Zoning Code, David Reyes stated that staff will include the following three findings:

- a. Circumstances under which the permit or entitlement was granted have been changed by the applicant to a degree that one or more of the findings contained in the original permit or entitlement can no longer be made in a positive manner and the public health, safety, and welfare require revocation
- c. One or more of the conditions of the permit or entitlement have not been substantially fulfilled or have been violated
- f. The improvement/use allowed by the permit or entitlement has become detrimental to the public health, safety, or welfare, or the manner of operation constitutes or is creating a public nuisance.

Following further discussion, it was moved by Councilmember Madison, seconded by Councilmember Gordo, to approve the staff recommendation, amended to include the provision contained in PMC Section 17.78.090 (Permit Revocation or Modification) of the Zoning Code, based on the findings detailed above. (Absent: Councilmember Kennedy)

<u>CONTINUED PUBLIC HEARING</u>: CALL FOR REVIEW OF THE DESIGN COMMISSION'S DECISION ON AN APPLICATION FOR CONSOLIDATED DESIGN REVIEW FOR A NEW 112,205-SQUARE-FOOT, 5-STORY MEDICAL OFFICE AND RETAIL BUILDING AT 550-566 EAST COLORADO BOULEVARD <u>Recommendation</u>: It is recommended that the City Council remand the call for review of the Design Commission's approval of the application for Consolidated Design Review for a new 112,205-square-foot, 5-story medical office and retail building at 550-566 E. Colorado Boulevard to the Design Commission for further review.

David Reyes, Director of Planning and Community Development, summarized the staff report, and responded to questions.

Richard A. McDonald, representing the development team, spoke in favor of the staff recommendation.

Following a brief discussion, it was moved by Councilmember Wilson, seconded by Vice Mayor Hampton, approve the staff recommendation. (Absent: Councilmember Kennedy)

#### <u>PUBLIC HEARING</u>: ZONING CODE AMENDMENTS TO UPDATE REGULATIONS FOR SINGLE-ROOM OCCUPANCY USES

**Recommendation:** It is recommended that the City Council:

(1) Find that the Zoning Code Amendments are exempt from the California Environmental Quality Act ("CEQA") pursuant to Section 15305 (Class 5 – Minor Alterations to Land Use Limitations) and State CEQA Guidelines Section 15061(b)(3), that there are no features that distinguish this project from others in the exempt class, there are no unusual circumstances, and none of the exceptions to the exemptions apply;

(2) Adopt the Findings of Consistency with the General Plan (Attachment A of the agenda report); and

(3) Approve the amendments and direct the City Attorney to prepare an ordinance amending Sections 17.30.030, 17.50.300, and 17.80.020 to Title 17 (Zoning Code) of the Pasadena Municipal Code to make single-room occupancy a permitted use in all CD zoning districts and increase the maximum unit size to 375 square feet.

**Recommendation of the Planning Commission:** At a public hearing on November 13, 2019, the Planning Commission recommended that the City Council find that the Zoning Code Amendments are exempt from CEQA and approve the Zoning Code Amendments that would make single room occupancy (SRO) uses permitted without a Conditional Use Permit in all CD Zones and increase the maximum unit size for SRO uses to 375 square feet. The Planning Commission additionally recommended that the Zoning Code Amendments include eliminating any minimum parking requirement for SRO uses (Attachment B of the agenda report).

The City Clerk reported that the public hearing notice was published in the <u>Pasadena Star News</u> on February 24, 2020, and in the <u>Pasadena Journal</u> and the <u>Pasadena Weekly</u> on February 27, 2020 and March 5, 2020 and that 1 letter in support was received by the City Clerk's Office, which was distributed to the City Council, posted online, and made part of the public hearing record.

David Reyes, Director of Planning and Community Development, summarized the staff report, and responded to questions.

Councilmember McAustin asked staff to provide information on parking usage, once the Design Commission has reviewed the proposed project.

Councilmember Wilson asked staff to encourage the developer to adhere to the City's density bonuses and associated concessions rather than the state legislation.

Mr. Reyes stated that staff can amend the Conditional Use Permit (CUP) and/or Affordable Housing Concession Permit to include the following, "It is a matter of right in the Central District, so long as they (developer) are complying with existing rules or the City's menu options."

Following discussion, it was moved by Councilmember Wilson, seconded by Councilmember McAustin, to approve the staff recommendation, to include additional language that if the developer complies with City regulations, the project will go straight to Design Review, but if the project does not comply with City regulations, there will be a discretionary process. (Absent: Councilmembers Kennedy, Madison)
