Hi,

My name is Joe Bautista and I live at 1989 Casa Grande Street, right next to Marshall Fundamental.

As much as I hate new development, if a lot is to be built up, I would much prefer to see public, affordable housing built on Pasadena land as opposed to retail space. It doesn't necessarily have to be an either/or situation - for example, one could have mixed use where the first floor is retail and all floors above that are residential, but if I had to choose one over the other, it would be housing.

This is my main request, that Ed Tech and the City Council approve the development of Heritage Square South.

Secondarily, if we wish to keep small business owners in Pasadena, I believe we should begin looking into the possibility of rent control for commercial property. This has been done in other municipalities, including New York City, and while it may be controversial at this time, it may be the best bet for fully utilizing commercial space that is left vacant due to an undue hardship on small business owners to continually increase cash flow to keep up with rising rents.

Finally, if we want to limit development in Pasadena - specifically for housing - I think it behooves the City Council to consider a vacancy tax. What is a more wasteful use of land than to have a perfectly liveable unit of housing not occupied? This seems like an egregious waste when we have both residents on the street, homeless, and residents who wish to keep Pasadena from becoming overdeveloped.

I want to thank you for your unanimous approval of homeless senior housing and mixed use at Heritage Square South in 2018. You rightly thought that providing 69 units of homeless housing for seniors was a good idea given the growing population of homeless seniors in Pasadena at that time. This segment of our city's homeless population will undoubtedly increase dramatically as a result of the Covid 19 crisis and its economic fallout. The need for housing homeless seniors has now become a matter of life and death.

As you know, Heritage Square South has wide-spread community support from churches and neighbors in Northwest Pasadena as well as of the City Council, which gave it unanimous approval and wanted to fast track it.

Heritage Square is an ideal site since it close to amenities that this population needs: a pharmacy, grocery store, restaurants and public transportation. Heritage Square South is also next door to another senior facility that can provide supportive services.

Using this site for affordable housing is appropriate since it was purchased with HUD funding for this use. This proposal will not use the City's General Funds and will provide millions of dollars in economic benefits to our city

To Whom it May Concern;

My name is Patricia Cunliffe. I am a 59-year-old documentary filmmaker, artist & freelance journalist. My partner is a 73-year-old 80's hit songwriter & music professional. As impressive as that may sound - we have perfect credit & been tenants in the same house for 27 years - We are not homeowners. I just lost my part-time survival income bookkeeping job to a younger person willing to take less money. In fact, we aspire to poverty level. That is how poor we actually are.

You may have an opinion in your mind of the type of individuals who require affordable, income based senior housing. The truth is you have no idea how many people, some actually high-profile in the area, who worry constantly about what is to become of us! It is a very, very scary thought to wonder when it is our turn to be homeless...

I am begging you to please take compassion on fellow human beings over the revenue that could possibly be made from those who are willing to pay any price to become the majority & move out the current residents of our city. When I say move out - that does not even mean relocate. What that means is place on the street! Take a good look at the homeless population sleeping outside of the \$2,000,000.00 condos & please ask yourselves how this is even possible.

I BEG YOU to please find compassion in your hearts to utilize Heritage Square South for permanent supportive housing over any other usage....PLEASE!!!

No general funds are needed for Ed Tech and the Council to vote for:

1) Leasing land to the developer Bridge Housing Inc

2) Providing funding from the Housing Successor Low Income Housing Asset Fund and the Inclusionary Housing Trust Fund - so that no money is needed from the General Fund.

This project includes 15% local hire, 20% local contracting, and 30% local purchasing agreements - which will be of benefit to our economy during these scary times.

The fact that affordable housing advocates have been working for 3 years to achieve this goal is ludicrous! The idea that providing housing for Pasadena's low-income & homeless seniors is not the first thought in our elected officials minds is abominable!
