**SPECIAL MEETING**

The virtual meeting was convened pursuant to Executive Order N-29-20 issued by Governor Gavin Newsom on March 17, 2020, and was held solely by videoconference/teleconference

**CEREMONIAL MATTERS** Mayor Tornek read a declaration by the City Council condemning the September 27, 2020 attack on Armenia by Azerbaijan.

Mayor Tornek requested that the meeting be adjourned in memory of those that have suffered due to death and illness caused by COVID-19; and of the innocent victims of the September 27, 2020, military aggression between Armenia and Azerbaijan.

Councilmember Gordo requested that staff send a copy of the declaration to the City's sister city of Vanadzor, Armenia and that staff contact surrounding municipalities to request they make the same declaration. Councilmember Kennedy spoke on the need for the world to condemn the actions of the Azerbaijan government and stand with the people of Armenia.

Mayor Tornek announced a proclamation declaring October 2020 as "Employment of Persons with Disabilities Month," and "National Pedestrian Safety Month" in Pasadena.

Councilmember Kennedy recognize Mr. James Farr as the new Chair of the Accessibility and Disability Commission.

Laura Cornejo, Director of Transportation, acknowledged and thanked the Pasadena Complete Streets Coalition for their dedication in raising awareness on pedestrian safety; and

presented a PowerPoint presentation on the next steps for the Slow Streets Neighborhood Protection Plan.

Councilmembers Masuda and Gordo spoke on the passing of Tim Price, long-time president of the Daisy-Villa Neighborhood Association, expressed condolences to friends and family, and requested that the meeting be adjourned in his memory.

Vice Mayor Hampton connected to the meeting at 2:22 p.m.

### **COVID-19 UPDATE FROM CITY MANAGER AND PUBLIC HEALTH OFFICER**

Dr. Ying Ying Goh, MD, Director of Public Health, reported on the number of cases and deaths related to the COVID-19 pandemic occurring in Pasadena, as well as on a national and worldwide scale. She provided information on California's mandate that high risk businesses and operators continue outdoor services only, that the community proceed with cautious gradual sector openings, and provided an update regarding the restarting of in-person student instruction; and encouraged the community to get a flu vaccination. Dr. Goh expressed deepest sympathies for all individuals grieving the loss of loved ones due to COVID-19; and responded to questions.

Councilmember Gordo spoke on the need for staff to consider, anticipate, and provide the needed resources to support the re-opening of various sectors in the City, ensuring the proper implementation of safety protocols and community awareness.

Vice Mayor Hampton expressed concerns regarding the inequity that exists where various sectors of City businesses are allowed to operate, but yoga and boutique gyms are still prohibited.

Councilmember Wilson asked staff to prioritize returning student's to in-class learning, especially elementary students; and spoke on the need for a communication strategy related to guidance on celebrating Halloween.

Steve Mermell, City Manager, stated that once the City moves to the “red tier” of California’s Blueprint for a Safer Economy, there will be an opportunity for indoor operations of yoga studios and gyms; and responded to questions.

Councilmember Gordo spoke on the need for staff to consider what assistance can be provided by the City to address student mental health issues when returning to in-class learning, and asked that staff reach out to the Los Angeles County Department of Mental Health.

Mayor Tornek shared that he, along with Councilmember Kennedy and Vice Mayor Hampton, attended a Pasadena Unified School District (PUSD) event, and Eric Shahakian, Assistant Superintendent of Student Wellness and Support, provided an update on PUSD’s student mental health referral program.

Vice Mayor Hampton expressed concerns related to the closure of the Pasadena Ice Skating Center, while other ice skating rinks located in other cities are open and operating during the COVID-19 pandemic.

Councilmember Madison joined the meeting at 3:14 p.m.

### **GREAT PLATES DELIVERED SENIOR MEAL PROGRAM**

**Recommendation:** It is recommended that the City Council:

- (1) Find that this action is exempt under the California Environmental Quality Act (CEQA) in accordance with Section 15061(b)(3) (Common Sense Exemption);
- (2) Appropriate \$905,106 from Unappropriated General Fund fund balance to the Parks, Recreation and Community Services Fiscal Year 2021 Operating Budget to cover Great Plates Delivered expenses through October 9, 2020;
- (3) Provide direction to City staff regarding continued participation in the Great Plates Delivered program if it is extended by the State beyond the current end date of October 9, 2020, at a cost of \$466,000 per month; and
- (4) Should the Council direct continuation of the program, grant the proposed expenditure an exemption from the Competitive Selection process pursuant to Pasadena Municipal Code Section 4.08.049(B), contracts for which the City's best interests are served. (Budget Amendment No. 2021-10)

City Manager Mermell provided introductory comments, and Brenda Harvey-Williams, Director of Parks, Recreation, and Community Services, presented a PowerPoint on the item, with both responding to questions. Matt Hawkesworth, Director of Finance, provided information on the staff's expectations related to Federal Emergency Management Agency (FEMA) reimbursement for the Great Plates Delivered program, and responded to questions.

Councilmember Gordo expressed frustration with the lack of options or alternatives in the staff recommendation to provide meals for the 235 individuals that are receiving meals from the program. He spoke on the need for staff to provide an analysis on how the City can more efficiently and effectively provide meals for additional residents.

Councilmember McAustin stated that she believes the City cannot afford to continue with the program; and spoke on the need for staff to provide information on alternatives for meal and grocery assistance for the participants of the program. She stated that she cannot support continuing the program as she believes it is not in the City's best interests to use their dwindling financial reserves.

Councilmember Madison spoke in favor of the City continuing the program, as the City's expenditures will be reimbursed approximately 94% from FEMA; and the program has the dual benefit of helping both local restaurants and senior citizens. He requested that staff provide the financial details for the program.

Councilmember Wilson stated that the primary objective of the program is to keep restaurants open; and expressed disappointment on the lack of analysis that might explain the benefits this program has had on local restaurants, including potential losses to employment and businesses should the program be terminated. He asked staff to remain diligent in assessing the risk profile in terms of receiving reimbursement from FEMA. Councilmember Wilson spoke in favor of the program as a stimulus for employment in the City, but recognized the concerns regarding the possibility of not being reimbursed by FEMA in a timely manner.

Vice Mayor Hampton spoke in favor of continuing the program as it provides meals and positive mental health service to the participating senior citizens.

Councilmember Kennedy expressed concerns that the program is not providing the City enough benefits based on the program's costs. He asked staff to determine if the program can be minimized and still be effective. He spoke in favor of tabling the item so that staff may research the participating restaurateurs to determine if they will continue to participate in the program, if the program is minimized to provide less meals. In addition, he asked staff to develop a transitioning element to the program when it ends.

Councilmember Gordo asked staff to determine if the Los Angeles County's Great Plates Delivered Senior Meals program will include the City's restaurants, specifically the 22 that participate in the City's program, including contacting Supervisor Katheryn Barger to advocate on behalf of the City. He spoke in favor of continuing the City's program for one month, with staff to return with the information requested.

Mayor Tornek expressed concerns with indefinitely sustaining the program given the City's remaining reserve balance, however supported the City's continued participation until staff is able to provide participants adequate alternative programs or assistance.

City Clerk Jomsky, reported that 2 letters were received in support of extending the Great Plates Delivered Senior Meal program were received, distributed to the City Council, posted on-line, and made part of the public record from the following individuals:

### **AUTHORIZATION TO ENTER INTO CONTRACTS WITH LEE & RO, INC., AND YAO ENGINEERING, INC., TO PROVIDE ON-CALL ELECTRICAL ENGINEERING SERVICES FOR THE WATER AND POWER DEPARTMENT**

**Recommendation:** It is recommended that the City Council:

- (1) Find that the proposed action is not a project subject to the California Environmental Quality Act ("CEQA") pursuant to Section 21065 of CEQA and Sections 15060(c)(2), 15060(c)(3), and 15378 of the State CEQA Guidelines and, as such, no environmental document pursuant to CEQA is required;
- (2) Authorize the City Manager to enter into a contract for an amount not-to-exceed \$1,000,000 or four years, whichever comes first, as the result of a competitive selection process, pursuant to Pasadena Municipal Code Section 4.08.047, with Lee & Ro, Inc., ("Lee & Ro") to provide on-call electrical engineering services; and (Contract No. 31855)
- (3) Authorize the City Manager to enter into a contract for an amount not-to-exceed \$1,000,000 or four years, whichever comes

first, as the result of a competitive selection process, pursuant to Pasadena Municipal Code Section 4.08.047, with Yao Engineering, Inc., ("Yao") to provide on-call electrical engineering services. (Contract No. 31854)

**AUTHORIZATION TO ENTER INTO CONTRACTS WITH GENERAL PUMP COMPANY, INC., AND LAYNE CHRISTENSEN COMPANY TO PROVIDE LABOR AND MATERIALS FOR ON-CALL WELL AND PUMP MAINTENANCE FOR THE WATER AND POWER DEPARTMENT**

**Recommendation:** It is recommended that the City Council:

(1) Find that the proposed authorization is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Sections 15301 (Class 1 – Existing Facilities) and 15302 (Class 2 – Replacement or Reconstruction) and that there are no features that distinguish this project from others in the exempt classes and, therefore, there are no unusual circumstances;

(2) Authorize the City Manager to enter into a contract, as the result of a competitive selection process, pursuant to Pasadena Municipal Code Section 4.08.047, with General Pump Company, Inc., ("General Pump") for on-call well and pump maintenance in an amount not-to-exceed \$2,708,750 for five years, whichever comes first, which includes the base contract amount of \$2,462,500 and a contingency of \$246,250, to provide for any necessary change orders; and (Contract No. 31872)

(3) Authorize the City Manager to enter into a contract, as the result of a competitive selection process, pursuant to Pasadena Municipal Code Section 4.08.047, with Layne Christensen Company ("Layne Christensen") for on-call well and pump maintenance in an amount not-to-exceed \$2,708,750 for five years, whichever comes first, which includes the base contract amount of \$2,462,500 and a contingency of \$246,250, to provide for any necessary change orders. (Contract No. 31874)

**AUTHORIZATION TO ENTER INTO A CONTRACT WITH INTER-CON SECURITY SYSTEMS, INC., FOR CITYWIDE PARKING ENFORCEMENT SERVICES IN AN AMOUNT NOT-TO-EXCEED \$3,834,118 FOR THE INITIAL THREE-YEAR TERM**

**Recommendation:** It is recommended that the City Council:

(1) Find that the authorization to enter into a contract with Inter-Con Security Systems, Inc., for citywide parking enforcement services is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3);

(2) Authorize the City Manager to enter into a contract, as a result of a competitive selection process, as specified by Section 4.08.047 of the Pasadena Municipal Code, with Inter-Con Security

Systems, Inc., for citywide parking enforcement services on designated streets, lots and parking structures in an amount not-to-exceed \$3,834,118 for the initial three year term; and

(3) Authorize the City Manager to extend the contract for up to two additional one year terms, provided any increases do not exceed the increase in the change in the Los Angeles-Riverside-Orange County consumer's price index for the preceding 12 month period. (Contract No. 31881)

**CONTRACT AWARD TO BOB WONDRIES MOTORS (DBA: WONDRIES FLEET GROUP) FOR SERVICE AND REPAIR WORK ON CITY-OWNED FORD AUTOMOBILES FOR AN AMOUNT NOT-TO-EXCEED \$625,000 FOR UP TO FIVE YEARS**

**Recommendation:** It is recommended that the City Council:

(1) Find that this action is exempt under the California Environmental Quality Act (CEQA) in accordance with Section 15061(b)(3), the General Rule that CEQA only applies to projects that may have an effect on the environment; and

(2) Accept the bid dated July 31, 2020, submitted by Bob Wondries Motors dba Wondries Fleet Group (Bob Wondries) in response to specifications for Ford automobile service and repair; reject all other bids received; and authorize the City Manager to enter into a contract with Bob Wondries for an amount not-to-exceed \$375,000 (which includes \$9,000 in contingency) over a three-year period with the option for two additional one-year extensions in the annual amount of \$125,000 (which includes \$3,000 in contingency), at the discretion of the City Manager, for a maximum total contract length of five years and a total contract amount of \$625,000. (Contract No. 31870)

**APPROVAL OF FINAL TRACT MAP NO. 072733 FOR CREATION OF NINE AIR PARCELS FOR RESIDENTIAL CONDOMINIUM PURPOSES AT 109 NORTH HARKNESS AVENUE**

**Recommendation:** It is recommended that the City Council:

(1) Adopt a resolution to approve Final Tract Map No. 072733 for the creation of nine air parcels for residential condominium purposes; and (Resolution No. 9808)

(2) Authorize the City Clerk to execute the Certificate on the map showing the City's approval of said map.

**Recommendation of the Hearing Officer:** The subject tentative map was approved on October 21, 2015 by the Subdivision Hearing Officer, to be recorded within three years. A one-year extension through November 3, 2019 was granted in accordance with Section 17.64.040 of the Zoning Code. A second one-year extension through November 3, 2020 was granted per Resolution No. 9774 adopted on March 30, 2020 to suspend certain time limits to land use matters.

**AUTHORIZATION TO ENTER INTO A PURCHASE ORDER WITH VPLS SOLUTIONS, LLC FOR THE PURCHASE OF NETWORK DATA COMMUNICATIONS EQUIPMENT AND SERVICES**

**Recommendation:** It is recommended that the City Council:

- (2) Authorize the issuance of a purchase order with VPLS Solutions, LLC, a certified California small business, in an amount not-to-exceed \$325,000. Competitive bidding is not required pursuant to City Charter Section 1002(H), contracts with other governmental entities or their contractors for labor, material, supplies or services; and

So, I am strongly in support of this measure and I hope there would be enough members of such a diverse City that we would find the necessary votes to move this forward as a Council recognizing the diversity in our City."

Councilmember Kennedy spoke in favor of supporting Measure J, which he believes minorities in various counties and cities have been disproportionately impacted by a desire of law enforcement to lock up people as a way to solve crime.

Councilmembers Masuda and Wilson spoke in opposition to the Los Angeles County ballot Measure J; and expressed concerns with forcing budgetary decisions on the Board through the ballot box.

Councilmember Gordo expressed concerns with the lack of analysis on the finances and impacts related to the measures from staff or LPC; and the Los Angeles County Board of Supervisors (Board) historical lack of actions that benefit the City's residents.

City Manager Mermell provided information on the City's fiscal amount of contribution towards Measure H and the funds received from Los Angeles County to combat and prevent homelessness.

Councilmember Madison spoke in support of Measure J, as the measure notes that during its budgetary decisions, the Board should address disproportionate impacts of racial injustice, and promote youth development, job training, and alternatives to incarceration, which are all programs that the community needs.

**POTENTIAL HOUSING FOR THE HOMELESS AT RELIGIOUS INSTITUTIONS**

**Recommendation:** It is recommended that the City Council receive the report and consider whether to provide direction to staff or the Planning Commission.

David Reyes, Director of Planning and Community Development, presented a PowerPoint presentation on the item, including potential temporary and permanent possible housing on religious facilities; and responded to questions.

Councilmember Wilson spoke on the City's inability to meet housing goals, and spoke in favor of staff developing a process to determine if there are opportunities to allow transitional housing at religious institutions.

In response to Councilmember Gordo's inquiry related to the Salvation Army Project, City Manager Mermell responded that the project includes 66 units plus a food bank.

Councilmember Gordo expressed concerns with a religious institution property that hires a developer, increases the density on the site, raises the value of the property, allows the property to include market-rate housing, and then allows the religious institution to sell a portion of the property and move location.

Mayor Tornek expressed strong support for the concept of allowing underutilized religious properties to be converted to affordable housing; and spoke on the need to establish minimal standards, asserting that there will not be huge impacts to the surrounding neighbors.

Councilmember McAustin spoke in favor of moving forward with amending the City's Zoning Code to allow for housing on the property of religious institutions, however expressed concerns with too much market-rate housing being allowed.

Councilmember Masuda spoke on the need for additional input from the community on the matter; and expressed concerns with market-rate development in neighborhoods.

Councilmember Gordo expressed concerns with moving forward with the matter without sufficient discussion. He stated his preference that the Planning Commission, affordable housing advocates, and the community be provided with additional opportunities for public discussion on the matter in a thoughtful process, but with a sense of urgency. He asked staff to include as part of any review or analysis, religious institutions, La Salle College Preparatory, Maranatha High School, and Assumption of the Blessed Virgin Mary School, and others on the interplay for potential housing.

Councilmember Wilson spoke in favor of forwarding the matter to the Planning Commission with a sense of urgency to work with staff, including a community outreach process, and return to the City Council in early 2021 with an updated report on the matter.

Following discussion, by consensus of the City Council, and on order of the Mayor, the information was received and filed.
