CEREMONIAL MATTERS

Mayor Tornek requested that the meeting be adjourned in memory of those that have suffered due to death and illness caused by COVID-19; all first responders and individuals suffering due to the wild fires throughout California; and the victims of recent gun violence in the City.

Mayor Tornek introduced and welcomed the new Sergeant-at-Arms, Sergeant Thomas Blanchard, and extended appreciation to Sergeant Monica Cuellar for her service.

Mayor Tornek recognized and spoke on Hispanic & Latino Heritage Month, from September 15, 2020 through October 15, 2020, and read a proclamation honoring its importance to the City and community members.

Vice Mayor Hampton, and Councilmembers Gordo, and Kennedy spoke on the need to visually recognize Hispanic & Latino Heritage month abiding by social distancing regulations and safety measures. Councilmember Gordo requested that the Pasadena Central Library commence a reading program or highlight movies/documentaries as an effort to raise awareness and recognize the contributions of Latinos; and to continue such a program with all heritages that make up the community of Pasadena.

Steve Mermell, City Manager responded that he would meet with staff to determine alternative methods to commemorate Hispanic & Latino Heritage month. He provided an update on the Los Angeles Bobcat Fire, including information on evacuation orders and warnings to effected city residents, and responded to questions.

Councilmembers Kennedy and Gordo, and Vice Mayor Hampton spoke on recent gun violence in the City, specifically the shooting of two minors, and the shooting of two Los Angeles Police Officers, and on Pasadena Police Officers' efforts to keep the community safe. Councilmember Gordo spoke in favor of the City joining with the City of Los Angeles in asking for peace.

Vice Mayor Hampton requested that staff provide information on air quality and smoke inhalation impacts affecting the public and Pasadena's community members.

Councilmember Masuda asked staff to provide information on the Pasadena Local Emergency Alert System (PLEAS) and Nixle alerts related to the Bobcat Fire.

He spoke in favor of approving the contract for just a three-year period only, in order to provide local contractors opportunities to bid on the contract.

Ara Maloyan, Director of Public Works, provided information on the scope of the project, which includes tree cutting and stump removal, and responded to questions.

Councilmember Kennedy spoke on the recent drug overdoses in the City, and on the need for the community to be vigilant and share information with the Pasadena Police Department related to the drug overdoses.

FINANCE COMMITTEE: RESIDENTIAL IMPACT FEE 2020 NEXUS STUDY UPDATE

Recommendation: It is recommended that the City Council:

(1) Find the amendments proposed in the agenda report are exempt from environmental review pursuant to State California

Environmental Quality Act (CEQA) Guidelines Section 15061(b)(3) ("general rule") Section 15378(b)(4) (definition of project excludes government fiscal activities which do not involve any commitment to any specific project);

Ara Maloyan, Director of Public Works, provided information contained in the agenda report that was difficult to read due to copying issues; and responded to questions.

Mayor Tornek, Chair of the Finance Committee, summarized the Committee's discussion on the item.

REGIONAL HOUSING NEEDS ASSESSMENT (RHNA AND HOUSING ELEMENT UPDATE)

<u>Recommendation</u>: It is recommended that the City Council receive the report on the Regional Housing Needs Assessment and provide any related direction to staff.

AUTHORIZATION TO ENTER INTO A CONTRACT WITH MIG FOR AN AMOUNT NOT-TO-EXCEED \$374,655 TO PROVIDE CONSULTING SERVICES FOR THE PREPARATION OF THE 2021-2029 HOUSING ELEMENT UPDATE

Recommendation: It is recommended that the City Council:

- (1) Find that the action proposed in the agenda report is not a project subject to the California Environmental Quality Act ("CEQA") as defined in Section 21065 of CEQA and the State CEQA Guidelines Section 15060(c)(2), 15060(c)(3), and 15378; and
- (2) Authorize the City Manager to enter into a contract as a result of a competitive selection process pursuant to Pasadena Municipal Code Section 4.08.047 with MIG for an amount not-to-exceed \$374,655 for the preparation of the 2021-2029 Housing Element update. (Contract No. 31843)

The two above agenda items were discussed concurrently.

David Reyes, Director of Planning and Community Development, provided introductory comments, and Arlene Granadosin-Jones, City Planner, presented a PowerPoint presentation on the item, with both responding to questions.

Councilmember Gordo spoke in favor of utilizing the same consultant that is being recommended to assist the City with the preparation of the 2021-2029 Housing Element update, to develop an appeal on the Regional Housing Needs Assessment (RHNA) allocations. He spoke in favor of appealing the RHNA's allocation, and consider joining with other large municipalities, including cities in the region and the San Gabriel Valley. He also spoke in favor of joining surrounding municipalities in litigation action against Southern California Association of Governments (SCAG) for the unachievable allocation numbers and encroachment into local control. He expressed strong concerns regarding the unfair treatment of Pasadena in light of other cities that have not made good faith efforts to construct affordable housing towards the regional housing goals. He spoke in favor of rejoining the San Gabriel Valley Council of Governments and partnering with surrounding cities to advocate as a region.

Councilmembers Masuda and Wilson spoke in favor of challenging the COG in setting unrealistic and unattainable RHNA's allocations.

Councilmember McAustin spoke in favor of challenging the RHNA's allocations on several levels, appealing the RHNA's allocations, and the need to continue to approach the City's land use on a sustainability basis. In addition, she also spoke on the need to educate the California Department of Housing and Community Development (HCD), in a meaningful and methodical manner, on the City's support of housing within the scope of a sustainable community, the City's track record in building affordable housing (in comparison to other municipalities), and the City's desire to provide its share of affordable housing within the confines of the City's ability to provide such housing.

City Manager Mermell suggested that the City Council consider approving an additional allocation of \$30,000 with MIG (separate item on the agenda for preparation of the City's 2021-2029 Housing Element) to allow the consultant to provide advice and preparation of the RHNA allocation appeal.

Councilmember Madison expressed concerns with RHNA allocation that mandates the City to severely increase housing density and impact the character of the community; and spoke in favor of appealing the RHNA allocation and all options, including litigation, becoming part of a consortium cities for this effort, and lobbying the State's legislative bodies including the State Senate. Councilmember Kennedy requested that staff provide information to the City Council on the pros and cons of filing a RHNA allocation appeal. He spoke on the need for the City Council to make a policy decision to build one thousand units of housing in a three-year period. The units should be for extremely-low, very-low, and low income salary categories.

City Clerk Jomsky reported that letters in support of building additional housing units, suggestions on how to meet RHNA allocations, expressing concerns with the RHNA allocation, advocating support for appealing RHNA allocations, and/or providing comments on the item, were received, distributed and make part of the public record from the following individuals:

Councilmember Wilson spoke in support of advocating for manageable affordable housing development with state legislative representatives that promotes a sustainable community; and recommended that staff be directed to initiate the appeal process of the RHNA allocation, with staff to return with information on the pros and cons of an appeal, as well as details on the arguments to be used to support the City's appeal. In addition, he spoke in support of the additional allocation of funds for the appeal, and to direct the MIG consultant and staff to determine the City's housing unit targets that reflect the needs of the community and the City's goals.

Councilmember McAustin spoke in favor of a Councilmember Kennedy's recommendation to develop a policy on the City building one thousand units of affordable housing in a three-year period.

Mayor Tornek spoke in favor of an appeal of the RHNA allocation and summarized the staff direction as: direct the staff to quickly provide a recommended appeal argument, including pros and cons of an appeal, and information on the likelihood of success.

Councilmember Gordo stated that his motion includes that the City Council approves the appeal of the City's DRAFT RHNA allocation by SCAG and HCD; and simultaneously moves forward with staff to return on litigation aspects, direct the consultant to begin preparing the City's Housing Element to ensure the City's continued compliance, the consultant to provide information on real achievable goals, and staff to provide information on best strategies and pitfalls related to the appeal process and litigation.

City Clerk Jomsky read aloud comments in support of the contract agreement with MIG to provide consulting services, from Anthony Manousos, Pasadena resident.

David Reyes, Director of Planning and Community Development, presented a PowerPoint on the MIG Consulting Contract agenda item; and responded to questions.

favor of the staff Councilmember Gordo spoke in recommendation, and also advocated for the recommended amendment to increase the proposed contract by an amount of \$30,000 and to utilize the consultant to assist in the preparation of the RHNA allocation appeal process (as discussed and detailed above), assisting staff and the City Council in setting realistic housing goals for the City. He suggested a closed session meeting with City Council and the consultant to discuss litigation, the potential appeal, and help identify reasonable goals regarding the number of affordable housing units to construct in Pasadena.

Councilmember Kennedy stated that he will reticently support the motion as he believes the City Council should display a united front on the item, however, he noted that he believes information is missing (pros and cons of an appeal), and would like that information to return at a future City Council meeting.

Following discussion, it was moved by Councilmember Gordo, seconded by Councilmember Wilson, to direct staff to work with MIG to prepare an appeal of the City's DRAFT RHNA allocation; consider joining with other large municipalities, including cities in the region and the San Gabriel Valley, in preparing a regional approach and effort to oppose and reduce the proposed RHNA requirements, including the possibility of exploring potential litigation; and approve the staff recommendation to enter into a

contract with MIG for an amount not-to-exceed \$374,655 for the preparation of the 2021-2029 Housing Element update, amended to include an additional allocation to MIG in the amount of \$30,000 for consultant services to support the RHNA allocation appeal process:
