Pasadena Police Department is requesting authorization to purchase 3 new Automated License Plate Readers (ALPRs) from Vigilant Solutions company. PPD takes many thousands of photos of license plates in Pasadena monthly and stores them for 2 years. Their stated purpose is to help identify stolen cars and help in criminal investigations.

Pasadena Privacy for All opposes this purchase from Vigilant Solutions, which provides both a hardware and service agreement, and which shares PPD's ALPR data with Homeland Security. Privately owned and profit-driven surveillance databases are an expanding threat to civil liberties and civil rights.

ICE has access to PPD's data via Homeland Security and the massive data broker, Thompson-Reuters according to Freedom of Information Act records received by the ACLU of Northern California.

PPD denies it allows transmission of ALPR data to ICE. Apparently it does not know of the above routing, or care to investigate after being informed

Pasadena is a Sanctuary City and prohibits trafficking with ICE.
