# **Comments:**

I have raised many concerns with the proposed ordinance creating the Police Oversight Commission (CPOC) and Independent Police Auditor (IPA) in a letter to the Council. The ordinance tilts too far toward the interests of law enforcement at the expense of independence, transparency, and accountability. Significantly, the duties of the IPA fail to expressly include conducting real time, independent investigations. The IPA only reviews uses of force, etc. to assess whether the PPD's investigation was complete. This is inconsistent with the independence the community has demanded. Further, the proposed ordinance allows the IPA to be present at the PPD's interviews only "where feasible." It is left up to the PPD, which is inconsistent with transparency. Additionally, the subpoena process is defective because it does not allow subpoenas for testimony of city employees, it requires the subpoenas to be served by the PPD, thus telegraphing the IPA's investigatory activities, and it does not provide a mechanism for enforcement. Finally, the ordinance must expressly state that communications between the IPA and the CPOC or City Council are not subject to the attorney-client privilege or, in the alternative, that the privilege is waived. Otherwise the IPA's reports can be withheld from the public.

Due to the efforts of community members the Council now has been directed to implement a long overdue system of public accountability to the PDD by creating an Oversight Commission and Independent Police Auditor. However the current language lacks the transparency and power to deliver justice to the hands of the people and must be amended.

First the Council must grant the IPA Investigatory Authority. As currently defined, the IPA can only review investigations, but in order to truly oversee the police, it must be empowered to Conduct Real-Time, Independent Investigations to the furthest extent of the law without bureaucratic limitations.

The Ordinance must commit the Commission and IPA to Transparency, as much as the law allows. Providing for public input to the selection process for Commission members and the IPA, residents having direct access to the Oversight Commission for the purposes of filing and following-up on complaints, and share investigatory outcomes with the public.
