My name is Jeehong Min and I am a board member of Vision Christian Fellowship in Pasadena, CA.

We desperately need more affordable housing in Pasadena! Even in our relatively small congregation, of which 150 or so are adults, we have ministered to 3 men and 2 women who have faced homelessness in the past few years. If there were more affordable housing, these ones would not have to face homelessness and trek across Los Angeles looking for temporary shelters many of which are full. My parents live in affordable housing in Pasadena - they are very fortunate, but the wait list is currently 5 years.

There are two major opportunities to increase affordable housing in Pasadena:

- 1. Affordable housing on the Water and Power site in the civic center.
- 2. Temporary shelter and affordable housing on church land.

The Water and Power site has been sitting vacant for many, many years and is certainly "surplus" land which the law prioritizes for affordable housing. Furthermore, the need for this housing is great! Please do all that you can to speed this process along!

Churches across Pasadena are stepping up to offer their land for temporary shelter and affordable housing, but they need the zoning to be changed to let them do that!
