My name is Jazmine De La Torre, I am a Pasadena resident.

Pasadena's adopted Zero Waste Plan is in serious trouble. Since the Pasadena City Council adopted the City's Zero Waste Plan in October 2014, the only substantial step towards reducing the amount of single-use plastic entering the City's waste stream was the adoption of a single-use polystyrene ordinance in May 2016, an effort supported by over a dozen local organizations and hundreds of Pasadena residents. Over the past five years progress has stalled. We now generate almost 50% more waste than we did when the Zero Waste Plan was approved in 2013. This worsening trend has only accelerated over the past year as the dramatic increase in takeout meant more non-recyclable waste from single-use containers, packaging, utensils, and other foodware accessories.

A local "Skip the Stuff" policy is arguably the easiest, yet still somewhat impactful, step the City can take to reduce the growing tide of single-use plastic at the local level. Supplying disposable foodware accessories only upon request can drastically reduce takeout and delivery waste. Most disposables go unused because restaurants automatically include them in takeout orders, which overwhelmingly are delivered to people's homes where customers do not need them. This local policy is also incredibly cost-effective for all parties involved, including the City, businesses, and customers.

Dear Mayor Gordo and Honorable Councilmembers,

Reusable LA is a coalition of organizations working to reduce plastic pollution in Los Angeles to safeguard our public health, communities, and environment. We envision a thriving culture of reuse and refill in Los Angeles to reduce waste from single-use plastic products and packaging as a model for communities to replicate. Reusable LA strongly supports the recommendation by the Pasadena Municipal Services Committee to draft a Disposable Food Service Ware "Skip the Stuff" ordinance. We would like to thank Director of Public Works Ara Maloyan for the comprehensive agenda report, presentation, and recommendations to the City Council and councilmembers Williams, Hampton, and Chair Wilson for their support and direction for this ordinance.

Restaurants and the online ordering platforms they use should default to providing no single-use accessories for orders unless the customer specifically requests them. Some platforms and restaurants have already switched to an accessories upon request model, but with an ever-changing landscape of delivery companies and restaurants, we need a legislative solution to ensure that the accessories on request model becomes permanent and normalized behavior in the greater Los Angeles region.

People in the United States use more than 36 billion disposable utensils a year. Laid end to end, they could wrap around the globe 139 times. Each year, billions of single-use plastic and paper accessories—utensils, straws, napkins, and condiments—are given to customers who order meals for take-out or delivery and don't need them. Most take-out and delivery meals go to homes and offices already stocked with reusable items.

The vast majority of these single-use items cannot be recycled. They add to the plastic pollution crisis that litters our streets, parks, rivers, and oceans and clogs already overfilled landfills. Cutting down trees and extracting more fossil fuels for items that aren't even used makes no sense in the middle of a climate crisis. These impacts also present significant environmental justice issues, with low-income communities and communities of color bearing a disproportionate burden of the impacts from climate change, fossil fuel extraction, and incineration associated with single-use waste.<sup>2</sup>

The COVID-19 pandemic has exacerbated the problem. Market research shows that digital food orders increased by 127 percent in the second quarter of 2020 compared with the same time last year.<sup>3</sup> Consumption of single-use plastics has increased by 250-300 percent since the pandemic began, resulting in a thirty-percent increase in waste, which is attributed to personal protective equipment (PPE), packaging, and disposable foodware.<sup>4</sup>

The pandemic has stressed our waste management systems to the brink and left our beloved restaurants in dire need of assistance. Nearly 100 restaurants in the LA region have closed permanently due to the pandemic, and hundreds more are struggling to keep their doors open, relying entirely upon takeout and delivery to do so due to city and county mandates. Evidence has shown that restaurants who switch to "opt-in" models and swap disposables for reusables can save between \$3,000 and \$21,000.6 Pasadena has a thriving restaurant community that could save thousands of dollars by switching to a convenient "opt-in" model. When restaurants provide accessories only upon request, they save money and prevent waste at the same time, benefiting everyone.

Reusable LA strongly supports a "Skip the Stuff" ordinance for the City of Pasadena. This ordinance is a win-win for businesses and communities, and would help fulfill the city's Zero Waste Plan. Cities across the state have already adopted or are in the process of adopting this legislation, and we urge Pasadena to follow suit. Good morning, I hope all is well and thank you for your reply. As we've partnered with other cities on their upon request policies, such as Los Angeles, we've provided the following feedback and questions for consideration by elected officials and staff:

Allow restaurant staff to initiate the ask: This avoids a customer forgetting to request utensils and avoids escalating conflicts between customers and employees.

Allow for utensils in self-service dispensers: We believe this is in line with the spirit of the law in reducing utensil consumption since the customer can choose whether or not they need utensils.

Pre-packaged items: If a product is pre-packaged outside of the restaurant or city, can a straw can be provided (i.e. juice boxes).

Lids- Exempt lids from any proposal for safety reasons

Any upon request policy should include a public awareness campaign period in which enforcement is delayed to allow time for the industry and customers to change behavior.

At McDonald's, we want to be a part of the solution in reducing our footprint and using our scale for good. I've attached a one pager which focuses on five bold commitments we made as a company to have a meaningful global impact.



Dear Council Members,

On behalf of the California Restaurant Association (CRA), and the restaurants in the City of Pasadena, I am writing to express our position for the proposed recommendations set forth by the Department of Public Works to create a disposable food service ware "upon request" ordinance. The recommendations outlined by the department aims to reduce the environmental impacts of disposable food accessories, while still allowing the local restaurant community to continue to focus on operating as an essential service in the midst of the pandemic- and beyond.

COVID-19 has led to the closure of thousands of restaurants and those that are still open have been required to adjust their operations to only takeout and delivery and most recently to extremely limited outdoor and indoor dining. Limiting onsite dining certainly increases consumer demand for food-ware accessories. The restaurant community shares the ongoing concern over unnecessary use of single-use products and routinely partners on litter abatement efforts at the state and local levels, works towards mitigating the impact on local landfills, continues to engage in public policy to encourage recycling and reduce food waste, and increase guest awareness about the unnecessary distribution of single-use products.

Representing all types of restaurants within the local community, we look forward to continuing to work with the city on the proposed recommendations for a disposable food service ware "upon request" ordinance. It is critical for the city to develop policy that takes into account the inner operational workings of a restaurant and allows restaurants to both offer- and provide to those requesting-food accessories. This model helps facilitate customer choice, eliminates customer inconvenience, frustration, and backlash towards employees when customers are not offered- or provided- the expected accessories to safely consume their meal. Consistent with the spirit of "upon request" it is important for any proposed ordinance to allow self-serve dispensers to be used, giving patrons the ability to choose if they need a utensil or not, while not negatively impacting restaurant operations and the experience of other guests. Additionally, the recommendations by the Department of Public Works looks to develop a public awareness campaign to notify restaurateurs and guests of the new policy- an essential component of changing public behavior and reducing waste.

We remain committed to working cooperatively to help the city design food service accessory policy that works for everyone and I look forward to continuing to work with you.
