7. What specifically in your background, training, education, or interests qualifies you as an appointee?

<u>Public Service</u> – I have been extremely fortunate in the opportunities and experiences I have had in life and have dedicated my career to public service as a way to give back and help others. I have served as a deputy attorney general, deputy county counsel, army reservist, and City commissioner. Serving on the Council would be a natural extension of my years of service and I would be honored to serve in this new role.

Experience in Government – My experience in government at the local, state, and federal levels will make me an effective advocate for my district and an asset to the Council from day one. I have developed a deep understanding of the day to day functions of government and awareness of the larger statutory, regulatory, and political context. In short, I have honed my practice of what Ken Burns has described as the "much maligned, but subtle art of governance."

Representation – It is important for our governing bodies to reflect the people they represent and the Council should represent the rich diversity of Pasadena. As a working mother with a small child, I will add an important perspective to the Council, which has had very few women members through the years. Additionally, as a Latina and someone who comes from a family of immigrants, I will strive to ensure that these underrepresented communities have a voice on the Council.

8. What do you see as the objectives and goals of the City Council?

The City's mission reads: "The City of Pasadena is dedicated to delivering exemplary municipal services responsive to our entire community and consistent with our history, culture and unique character." Additionally, per our Charter, "The City Council is empowered to carry into effect the provisions of this Charter, to execute the powers vested in the City, and to perform all duties and obligations imposed upon the City by State law." These guiding principles clearly set out the Council's objectives and goals. However, I would add that during these incredibly trying times, it is paramount that the Council also set an example of steady leadership that respects the dignity and worth of each resident.

9. How would you help achieve these objectives and goals? What special qualities would you bring?

I have extensive experience working with the various individuals, entities, and stakeholders that the Council regularly engages with: different departments, commissions, workgroups, community groups, constituents, other public entities, joint powers authorities, insurers, attorneys, etc.

I am able to thoroughly review and process a large amount of information without losing sight of the big picture. I would be able to review the materials prepared by staff and feedback from constituents in order to collaborate with the other Councilmembers to find solutions to the challenges we face.

Finally, both my civilian and military experience has instilled in me the discipline necessary for this new responsibility. I prioritize teamwork, comradery, and focusing on accomplishing the mission.

In short, I will immediately be a helpful colleague to the Mayor and Councilmembers as well as an effective representative for my District 5 neighbors.
