It is a 1914 Bungalow, located in Bungalow Heaven, the first Historic District in Pasadena, organized in 1989 by the Bungalow Heaven Neighborhood Association (BHNA). I have served several times as a docent for the BHNA Historic Homes tour. I have also served several times as a docent for the Heritage Home tours.

The first time I considered being a candidate for city council was when Steve Acker was elected. John Crowley took me to lunch back then and helped give me some direction. Jo Heckman was also a strong mentor when I was vice-chair with her in the Pasadena Sister Cities Committee. I have been involved in many community activities since those times and have built on my community involvement, which I believe can add insight, knowledge and an appreciation for the community to our city council. I know that the city is not just the council as individuals, it is the collective group. It takes each person doing their part to make it work. All the council members, the mayor, the city manager, the city clerk, the city attorney and everyone doing their part. I was reflecting on this aspect, because of our homeless person issue and I was thinking about the Bad Weather Shelter. So many people in the community are upset because it is not going this year the way it has in the past. I have been involved for several years doing my small part to help. This year my church was offering to use our facility to shelter the women, so we were involved in the planning for this year. It is not all about money, or vouchers for rooms. The pandemic has brought so many other issues for all of us that it is impossible to solve them all. This is somewhat simplistic; however it caused me to reflect on our Food Bank and how I do my part in the group by ordering, picking up, setting up, and helping to hand out. I could not do it alone many others are involved. Same with my military time I was just a part of the many with each of us doing their individual part.
