### **Comments:**

Mark Maier, Pasadena resident, speaking for Pasadenans Organizing for Progress in response to public comment by the Chamber of Commerce and the California Grocer's Association.

- 1. Profits at groceries should not be measured as percentage of sales as in the Chamber comment. Instead profits measured by return on investment show enormous profits, \$6.8 billion for the chains covered by the ordinance.
- 2. Store closures are unrelated to other city ordinances. The closures will take place near the end of the 120 day hero pay, thus not saving store costs as they contend.
- 3. Most of the bonus pay described has now lapsed. One exception is Trader Joes, an example demonstrating that responsible businesses can afford hero pay. In other jurisdictions, TJs has been given credit for the policy already in place.
- 4. The majority of grocery and pharmacies covered in Pasadena are not unionized.
- 5. Despite maintaining their employment, grocery and pharmacy workers face accumulated debt and rent shortfalls that Hero Pay can help remedy.
- 6. Pay for full time, full year grocery workers with families do not have a livable wage in Pasadena and their children qualify for benefits in the public schools.

I live in South Pasadena. I frequent Pasadena grocery stores. I urge you to pass a hazard pay ordinance for Pasadena workers.

Jurisdictions around California are moving forward with hazard pay for retail workers. The momentum behind local hazard pay ordinances is logical given the stunning profits earned by major retailers in 2020, while frontline workers have risked illness and death for low wages. According to the Brookings Institution, in 2020, Kroger's profits were up 90%, up \$962 million from 2019. Albertsons' profits were up 153% over the previous year, from \$344 million to \$871 million.

The Brookings Institution report also found that, when available, hazard pay makes a meaningful difference for low-wage retail workers, particularly for women and people of color. Requiring retailers to give a modest pay bump to workers is a concrete measure Pasadena can take to address the pandemic's racial inequities.

Pasadena should not retreat from good policy in fear of the grocery associations' intimidation tactics. On February 25, a federal district court denied the Grocers Association's motion to temporarily overturn the Long Beach hero pay ordinance. Kroger's decision to close two retail locations in Long Beach has been pilloried as retaliation against essential workers.
