The proposed resolution for appointing members to the CPOC is woefully inadequate. It only requires each councilmember and the Mayor to present to the Council the name they wish to nominate. Theoretically, all of the members on the Council who have received substantial political campaign contributions from the police union (almost all members of the Council), could nominate current police officers to the Commission, even though they have conflicts of interest and should be banned from serving in the first place. Further, the Council previously expressed a desire to have the CPOC be ethnically, culturally and experientially diverse. How is that going to be accomplished if councilmembers simply submit names without any consideration of how the CPOC represents the interests of ALL Pasadena residents? The proposed resolution will not result in a Commission dedicated to, and capable of, providing effective oversight of the police department. Section 2.60.040 of the CPOC Ordinance does not spell out the required Commissioner training. Such training should include all of NACOLE's suggested training topics listed on Page 9 of Attachment 4 to the Agenda (internal page number 7 of the report). In addition, training in non-violent deescalation techniques and appropriate trauma care should be required.

POP welcomes today's council resolution establishing a COMMUNITY POLICE OVERSIGHT COMMISSION. For many community organizations and residents, this is the result of years of work for police reform.

We are disappointed there is no action today specifying the process for selecting and appointing the three members representing community-based organizations.

The community was promised during council meetings last year that a process would be articulated by either the Council or Public Safety Committee providing for selecting these commission members.

When will that process be spelled out? ---

Last summer, a coalition of six community groups led the call for a Police Oversight Commission and an Independent Police Auditor.

The organizations in the coalition are -- the National Association for the Advancement of Colored People, the National Day Laborer Organizing Network, the Coalition for Increased Civilian Oversight of Pasadena Police, the Interdenominational Ministerial Alliance, the Clergy Community Coalition and POP.

We are asking representatives from the six organizations be selected to serve on any panel nominating residents to represent community-based organizations.

Lastly, we expect ALL commissioners will be equal in status and terms for members representing the community will be staggered like other commissioners and will not expire all at once.
