SUBJECT:

Approval of a journal voucher to amend the FY 2001 - 2006 Capital Improvement

Program to include the "Rose Bowl Improvement" section.

RECOMMENDATION:

It is recommended that the City Council approve a journal voucher amending the FY 2001 - 2006 Capital Improvement Program to include the "Rose Bowl Improvement" section as detailed in the attachment.

BACKGROUND:

Rose Bowl staff presented their section of the CIP, "Rose Bowl Improvements", to the Finance Committee on July 24, 2000. The Committee decided to continue this discussion to August 14, 2000 at the City Council's joint meeting with the Rose Bowl Operating Company (RBOC) Board. The RBOC Board met on August 9, 2000 and recommends approval of the following Capital Improvement and Major Maintenance Plan for FY 2001: (1) An appropriation of \$1,547,385 for FY 2001 Stadium Capital Improvements funded by 1996 Rose Bowl Capital Improvement Bond surplus; (2) an appropriation of \$400,000 for Brookside Clubhouse Capital Improvements funded by FY 2000 RBOC Operating Surplus and 1996 Bond Surplus and (3) an appropriation of \$900,000 for Brookside Golf Course Capital Improvements funded by American Golf Corporation and the Greens Fee Funds.

Attachment I shows the specific spending limits for each capital project for FY 2001.

FISCAL IMPACT

Recommended appropriations in the "Rose Bowl Improvements" section FY 2001 Capital Improvement Program total \$2,847,385.
