CONCERNING PUSHCART VENDING IN PUBLIC PARKS

#### TITLE OF PROPOSED ORDINANCE:

AN ORDINANCE OF THE CITY OF PASADENA AMENDING SECTIONS 8.16.020 (G) AND 3.24.110 (A)(12) OF THE PASADENA MUNICIPAL CODE RELATED TO VENDING FROM PUSHCARTS IN PUBLIC PARKS

#### **PURPOSE OF ORDINANCE:**

The purpose of this ordinance is to permit pushcart vending in public parks for up to four hours in one location provided another group has not obtained a special events permit for concessions. Additionally, the proposed ordinance requires that if a pushcart remains in the park after four hours, it must be relocated at least 500 feet away from the previous location.

## **REASON WHY LEGISLATION IS NEEDED:**

The Municipal Code currently prohibits vending from pushcarts in public parks and can only be changed by amendment.

### PROGRAMS, DEPARTMENTS OR GROUPS AFFECTED:

Pushcart vendors and people using the public parks will be impacted by this ordinance. The Pasadena Public Health Department will continue to enforce all code violations relating to food vending.

### **POLICY CHANGES:**

Because pushcart vending in the public parks is currently illegal under the Municipal Code, this amendment would represent a policy change for the city.

AN ORDINANCE OF THE CITY OF PASADENA AMENDING SECTIONS 8.16.020 (G) AND 3.24.110 (A)(12) OF THE PASADENA MUNICIPAL CODE RELATED TO VENDING FROM PUSHCARTS IN PUBLIC PARKS

The People of the City of Pasadena ordain as follows:

**SECTION 1**. Subsection G of Section 8.16.020 of the Pasadena Municipal Code is hereby amended to read as follows:

"G. Pushcart vending shall be permitted in a public park for no more than 4 hours in one location, provided another entity or group using the park has not secured a special event permit for concessions. If a pushcart is moved to a subsequent location in the park, the new location shall be not less than 500 feet away from the prior location. It is unlawful to vend from pushcarts on other public properties, excluding public walkways in residential areas as authorized in subsection E, without a special event permit. Special event permits shall be required for New Year's Day, the Black History Festival, Cinco de Mayo and other events as determined by the city."

**SECTION 2.** Paragraph 12 of Subsection A of Section 3.24.110 of the Pasadena Municipal Code is hereby amended to read as follows:

"3.24.110 Prohibited acts.

A. No person shall do any of the acts hereinafter specified within the limits of any of the public parks of the city, the Civic Center, or the grounds of the branch libraries or other municipal buildings:

12. To sell or offer for sale any goods, merchandise, article or thing whatsoever without the written consent of the city manager, who shall give such consent only upon a satisfactory showing that the conduct is justified in the interest of the public convenience or comfort; except that pushcart vending is permitted in public parks in accord with the provisions of Section 8.16.020 (G);"
