1999 New Year's Day Event Budget

RECOMMENDATION

It is recommended that the City Council amend the Fiscal Year 1999 Operating Budget to include the 1999 New Year's Day event budget for the Parade and Post Parade activities. The recommended revenues and expenses are detailed in Attachment A.

BACKGROUND

As preparation begins for the 1999 New Year's Day activities, the department detail budgets for the Parade and Post Parade are being recommended for City Council approval. Included already in the Fiscal Year 1999 Operating Budget under the Rose Bowl Operating Company (RBOC) is the revenue and expenses for the Game. With the creation of the RBOC, the Parade and Post Parade expenses and revenues have been segregated from the Game activities and thus require a separate budget. In the past, all New Year's Day costs were accounted for in the Rose Bowl Fund.

The recommended budget reflects a net five percent increase over the fiscal year 1998 budget but is consistent with previous year's actual expenses. The estimated revenues are projected to remain constant for fiscal year 1999. Consistent with prior years, revenues received from the Parade subsidize the Post Parade activities. When staff prepared the fiscal year 1999 operating budget, a net operating income in the amount of \$180,000 from New Year's day activities was included as part of the projected ending fund balance.

FISCAL IMPACT

The fiscal impact associated with this recommendation will increase the General Fund revenues and appropriations in the amount of \$861,515 for funding of the 1999 New Year's Day Parade and Post Parade.
