SUBJECT:

Contract Award to Madison Paving Inc. for Improvement of

Oak Knoll Avenue from Green Street to California Boulevard

for an Amount Not to Exceed \$392,000

RECOMMENDATION:

It is recommended that the City Council:

- (1) Accept the bid, dated July 11, 2001, submitted by Madison Paving Inc. in response to the specifications for the Improvement of Oak Knoll Avenue from Green Street to California Boulevard, reject all other bids received, and authorize the City Manager to enter into such contract as required.
- (2) Acknowledge the project to be categorically exempt under Section 21084 of the California Environmental Quality Act (CEQA) in accordance with Article 19, Section 15301(c) of the Resources Agency of California Guidelines (repair of existing public streets) pursuant to the findings of the Secretary of the Resources Agency and authorize the City Manager to execute and the City Clerk to file a Notice of Exemption for the project with the Los Angeles County Clerk.

BACKGROUND:

Plans and specifications for the subject project, which is included in the adopted Capital Improvement Program, were prepared by the Public Works and Transportation Department. Bids have been requested and received.

The work on Oak Knoll Avenue from Green Street to California Boulevard consists of the excavation and removal of damaged concrete pavement and construction and resurfacing using conventional and rubberized asphalt concrete pavement over the entire roadway. This project also includes construction of Portland Cement Concrete (P.C.C.) gutter, curb, sidewalk, driveway, adjustment of utility manholes, and reinstallation of traffic striping.

A finding of compliance with the General Plan was previously made and is shown on page 2.5 of the FY 2001-2006 Capital Improvement Program.

Under the State Guidelines for the Implementation of the California Environmental Quality Act (CEQA), this project is categorically exempt since the work consists of the maintenance of an existing public street. Therefore, it is recommended that a Notice of Exemption be filed with the Los Angeles County Clerk.

This project was advertised in the <u>Pasadena Journal</u> on June 14, 2001. In addition, the Notice Inviting Bids was published in five trade publications. A total of thirty-seven bid packets were obtained by contractors.

Following advertising, bids were received on July 11, 2001 and are as follows:

The bid of Madison Paving Inc. is the lowest responsive and responsible bid. Therefore, it is recommended that they be awarded the contract for this project.

The proposed contract with Madison Paving Inc. fully complies with competitive bidding and Affirmative Action in Contracting Ordinance and the rules and regulations promulgated thereunder. The contractor selection process fully complied with this Ordinance and its rules and regulations. The contractor has indicated that the award of this contract will result in no new hires to his present workforce.

The contract for this project will be set up as follows:

Contingency Allowance	\$ 35,550.00
Contract "Not to Exceed" Amount	\$392,000.00

It is anticipated that construction will begin in late August 2001 and be completed in November 2001.

FISCAL IMPACT:

Sufficient funds are available in Budget Account 73876 (Improvement of Alleys and Concrete Streets). In addition, the Water and Power Department will fund approximately \$8,640 from Budget Account 8114 401 843130 30 0594 20221 for the Power Department and approximately \$3,360 from Budget Account 8114 402 883300 00 0761 00000 for the Water Department for adjustment of their facilities.
