AN UNCODIFIED ORDINANCE OF THE CITY OF PASADENA REPEALING ELEVEN NON-EXCLUSIVE FRANCHISES FOR SOLID WASTE COLLECTION

WHEREAS, Ordinance No. 6704, adopted on March 17, 1997, granted, pursuant to Chapter 8.61 of the Pasadena Municipal Code, a non-exclusive solid waste collection franchise ("Franchise") to five applicants; and

WHEREAS, Ordinance No. 6788 adopted on June 14, 1999, granted, pursuant to Chapter 8.61 of the Pasadena Municipal Code, a non-exclusive solid waste collection franchise ("Franchise") to forty-eight applicants; and

WHEREAS, one franchisee from the list of franchises granted under Ordinance 6704 and ten franchisees from the list granted under Ordinance 6788 have each requested voluntary termination of their franchise; and

WHEREAS, the City Council of the City of Pasadena approved at its meeting on April 2, 2001 to receive the said voluntary terminations of said eleven non-exclusive solid waste franchisees.

NOW THEREFORE, the People of the City of Pasadena ordain as follows:

SECTION 1. Section 3 of Ordinance No. 6704 which granted a non-exclusive franchise to National Construction Rentals dba National Waste Management is repealed.

SECTION 2. The following sections of Ordinance No. 6788 are repealed:

Section 5, which granted a non-exclusive franchise to Allwaste Industries;
