**AN ORDINANCE OF THE CITY OF PASADENA CONCERNING  
MERGER OF THE AFFIRMATIVE ACTION AND THE HUMAN  
RELATIONS COMMISSIONS, ELIMINATION OF TERM LIMITS  
FOR CODE ENFORCEMENT COMMISSIONERS, AND MODIFICATION  
OF THAT COMMISSION'S PURPOSE AND FUNCTION**

The People of the City of Pasadena ordain as follows:

**SECTION 1.** Pasadena Municipal Code, Chapter 2.85 ("Human Relations Commission"), Section 2.85.110, Subsection B is amended to read:

"The purpose of this commission is to aid the city in achieving better human relations **in city government**, and to provide assistance to private persons and groups in promoting good will and better relations among all people."

**SECTION 2.** Pasadena Municipal Code, Chapter 2.85 ("Human Relations Commission"), Section 2.85.110, Subsection C is amended to add a new Paragraph 10 to read:

"C. The commission shall:

**10. Formulate or recommend programs and policies for lessening prejudice, intolerance and discrimination in employment, housing and education for both the general public and the city organization."**

**SECTION 3.** Chapter 2.46 of Title 2 of the Pasadena Municipal Code ("Affirmative Action Commission") is hereby repealed.

**SECTION 4.** Pasadena Municipal Code, Chapter 2.55 (“Code Enforcement Commission”), Section 2.55.030, Subsection B is amended to read:

**“B. A member shall be appointed for an initial term of 3 years, and shall serve periodic three-year terms thereafter if re-nominated by the councilmember who originally nominated that member. Terms expire on June 30<sup>th</sup> of the applicable years. A member shall continue in office for the term for which he/she was appointed or until his/her successor is appointed.”**

**SECTION 5.** Pasadena Municipal Code, Chapter 2.55 (“Code Enforcement Commission”), Section 2.55.110 is hereby amended to read:

**“2.55.110 Purpose and functions.**

The **primary** purpose of the commission is to hear and rule on cases and appeals regarding enforcement of particular provisions in Title 6, 14, 17, **Chapter 8.48**, and Chapter 9.58 of this code, and to order action on cases of noncompliance presented by city staff. **The commission also advises the council on code enforcement matters and animal control issues.”**

**SECTION 6.** This ordinance shall take effect upon the date of its publication.


