SUBJECT: Contract Award to All American Asphalt
for the Preventive Maintenance of Streets - 2002
for an Amount Not to Exceed \$860,000

RECOMMENDATION:

It is recommended that the City Council:

1. Accept the bid dated May 29, 2002 submitted by All American Asphalt in response to the Specifications for the Preventive Maintenance of Streets - 2002, reject all other bids received, and authorize the City Manager to enter into such contract as is required.
2. Acknowledge the project to be categorically exempt under Section 21084 of the California Environmental Quality Act of 1984 in accordance with Article 19, Section 15301 (Class 1), subsection (c) of the Resources Agency of California Guidelines (maintenance of existing public streets) pursuant to the findings of the Secretary of the Resources Agency and authorize the City Manager to execute and the City Clerk to file a Notice of Exemption for the project with the Los Angeles County Clerk.
3. Approve a journal voucher recognizing private capital in the amount of \$4,342.50 and appropriating it to Budget Account No. 73710, Preventive Maintenance - Asphalt Streets.

BACKGROUND:

The subject project is included in the approved FY 2002 Capital Improvement Program Budget. In accordance with Pasadena Municipal Code Section 4.08.070, the Department of Public Works and Transportation has prepared plans and specifications for the subject project and bids have been requested and received.

This project consists of resurfacing of forty-three street segments covering 7.8 miles of City streets. A list of all street segments is attached.

The resurfacing work consists of the construction of an asphalt concrete overlay on the roadway after the existing asphalt pavement has been restored to a state of good repair. This work also includes localized roadway repair; cold milling; leveling; adjustment of utility manholes; and reinstallation of traffic striping.

A finding of compliance with the General Plan was previously made and is shown on page 2.1 of the FY 2002-2006 Capital Improvement Program.

Under the State Guidelines for the Implementation of the California Environmental Quality Act (CEQA), this project is categorically exempt since the work consists of the maintenance of existing public streets. Therefore, it is recommended that a Notice of Exemption be filed with the Los Angeles County Clerk.

This project was advertised in the Pasadena Journal on May 9, 2002. In addition, the Notice Inviting Bids was published in three trade publications.

Following advertising, bids were received on May 29, 2002 and are as follows:

It is recommended that All American Asphalt be awarded the contract for this project as they are the lowest responsive and responsible bidder and that all other bids be rejected.

The proposed contract with All American Asphalt fully complies with the competitive bidding ordinance and the rules and regulations promulgated thereunder as did the Contractor selection process. The Contractor has indicated that the award of this contract will result in no new hires to his present workforce.

The contract for this project will be set as follows:

Base Bid	\$781,255.00
Contingencies	<u>78,745.00</u>
CONTRACT NOT TO EXCEED	\$860,000.00

Construction will begin in July, 2002 and be complete in October, 2002.

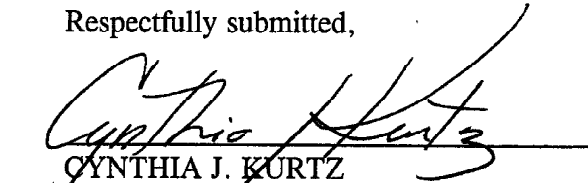
Funds from 5 property owners in the aggregate amount of \$4,342.50 were received to repair damaged sidewalk or driveways which are the property owners' responsibility. These funds were placed in Budget Account No. 73710.

It is necessary that a journal voucher be approved recognizing these funds and appropriating them to Budget Account 73710 (Preventive Maintenance - Asphalt Streets).


FISCAL IMPACT:

Funds for this project are available in Budget Account 73710 (Preventive Maintenance - Asphalt Streets). In addition, the Water and Power Department will fund approximately \$11,315.00 from Budget Accounts 8114-401-843130-30-0594-20221 and 8114-402-883300-00-0761-00000 for adjustment of their facilities.

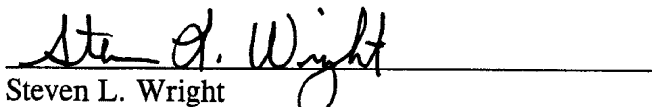
