BACKGROUND:

The Affirmative Action Commission was established in July 1988 created by Ordinance Number 6266 chapter 2.46 of the Municipal Code. The Affirmative Action Commission is among those currently under review by the City Council.

PURPOSE:

The purpose of the Commission includes the following:

- Ensures that the city embraces Title VII of the Civil Rights Act of 1964, the related provisions of the California Fair Employment and Housing Act and the Americans with Disabilities Act.
- Ensures that implementation of city policies and procedures affords all individuals an equal opportunity to succeed.
- Assists in preventing denial of opportunity to any individual because of race, sex, religious creed, sexual orientation, color, marital status, national origin, parental status, ancestry, disability, or age.
- Supports implementation of city policies and procedures requiring affirmative action relative to the city's employment, training, and contracting practices related to protected classes as defined in the applicable city ordinance.
- Advises and assists the Affirmative Action & Diversity Department with organizational initiatives that treat and respect all individuals equally, regardless of their differences.


There is no activity to report for the period of FY 2000-2001, and the Commission has not adopted a work plan for the current fiscal year.
