TITLE OF PROPOSED ORDINANCE: An Ordinance of the City of Pasadena Amending Chapter 1.20 ("Election Districts") of the Pasadena Municipal Code

#### PURPOSE OF ORDINANCE:

Every ten years, after the results of the federal decennial census are available, Council districts must be examined and revised as necessary to conform to applicable legal requirements.

### REASONS WHY LEGISLATION IS NEEDED:

Redistricting is accomplished by ordinance under section 1201 of the City Charter.

### PROGRAMS, DEPARTMENTS OR GROUPS AFFECTED:

Voters for City Council candidates, candidates and council members will be affected by the revised districts under the proposed ordinance.

#### ORDINANCE NO.

AN ORDINANCE OF THE CITY OF PASADENA AMENDING CHAPTER 1.20 ("ELECTION DISTRICTS") OF THE PASADENA MUNICIPAL CODE

The People of the City of Pasadena ordain as follows:

SECTION 1. Chapter 1.20 of the Pasadena Municipal Code is hereby amended by amending Section 1.20.020 through 1.20.090, inclusive to read:

"1.20.020 District No. 1.

District No. 1 shall be as follows:

All that portion of the city lying within the boundaries of the following described line: Beginning at the intersection of the Route 134 Ventura Freeway and Arroyo Seco Flood Control Channel; thence northerly along the Arroyo Seco Flood Control Channel to the intersection with the northerly prolongation of the Arroyo Seco Flood Control Channel; thence northerly along said prolongation to the intersection with Oak Grove Drive; thence westerly along Oak Grove Drive to the intersection with the northerly city boundary; thence along said city boundary in a generally northerly, easterly, southerly and easterly direction to the intersection with Lake Avenue; thence southerly along Lake Avenue to the intersection with Rio Grande Street; thence westerly along Rio Grande Street to the intersection with Ladera Street; thence westerly along Ladera Street to the intersection with Los Robles Avenue; thence northerly along Los Robles Avenue to the intersection with Howard Street; thence westerly along Howard Street to the intersection with Garfield Avenue; thence southerly along Garfield Avenue to the intersection with Washington

Boulevard; thence westerly along Washington Boulevard to the intersection with the Route 210 Foothill Freeway; thence southerly along the Route 210 Foothill Freeway to the intersection with State Highway 710; thence southerly along State Highway 710 to the intersection with Colorado Boulevard; thence westerly along Colorado Boulevard to the intersection with the Orange Grove offramp from the Route 134 Ventura Freeway; thence westerly along the Orange Grove offramp from the Route 134 Ventura Freeway to the intersection with the Route 134 Ventura Freeway; thence westerly along the Route 134 Ventura Freeway to the point of beginning.

#### "1.20.030 District No. 2.

District No. 2 shall be as follows:

All that portion of the city lying within the boundaries of the following described line: Beginning at the intersection of Colorado Boulevard and Wilson avenue; thence northerly along Wilson Avenue to the intersection with Maple Street; thence easterly along Maple Street to the intersection with Chester Avenue; thence northerly along Chester Avenue to the intersection with Orange Grove Boulevard; thence westerly along Orange Grove Boulevard to the intersection with Michigan Avenue; thence northerly along Michigan Avenue to the intersection with Mountain Street; thence westerly along Mountain Street to the intersection with Catalina Avenue; thence northerly along Catalina Avenue to the intersection with Claremont Street; thence westerly along Claremont Street to the intersection with Lake Avenue; thence northerly along Lake Avenue to the intersection with the northerly city boundary; thence along said city boundary in a generally easterly, southerly and easterly direction, in its various courses, to the intersection with Martelo Avenue; thence southerly along Martelo Avenue to the intersection with Casa Grande

Street; thence westerly along Casa Grande Street to the intersection with Craig Avenue; thence southerly along Craig Avenue to the intersection with Mountain Street; thence westerly along Mountain Street to the intersection with Palo Verde Avenue; thence southerly along Palo Verde Avenue to the intersection with the Route 210 Foothill Freeway; thence easterly to the intersection with Oak Avenue; thence southerly on Oak Avenue to the intersection with Colorado Boulevard; thence westerly along Colorado Boulevard to the point of beginning.

#### "1.20.040 District No. 3.

District No. 3 shall be as follows:

All that portion of the city lying within the boundaries of the following described line: Beginning at the intersection of Colorado Boulevard and State Highway 710; thence northerly along State Highway 710 to the intersection with the Route 210 Foothill Freeway; thence northerly along the Route 210 Foothill Freeway to the intersection with Washington Boulevard; thence easterly along Washington Boulevard to the intersection with Garfield Avenue; thence northerly along Garfield Avenue to the intersection with Howard Street; thence easterly along Howard Street to the intersection with Los Robles Avenue; thence southerly along Los Robles Avenue to the intersection with Ladera Street; thence easterly along Ladera Street to the intersection with El Molino Avenue; thence southerly along El Molino Avenue to the intersection with Jackson Street; thence westerly along Jackson Street to the intersection with Douglas Street; thence westerly along Douglas Street to the intersection with Garfield Avenue; thence southerly along Garfield Avenue to the intersection with to Mountain Street; thence westerly along Mountain Street to the intersection with to Mountain Street; thence westerly along Mountain Street to the

intersection with Worcester Avenue; thence southerly along Worcester Avenue to the intersection with Orange Grove Boulevard; thence westerly along Orange Grove Boulevard to the intersection with Fair Oaks Avenue; thence southerly along Fair Oaks Avenue to the intersection with the Route 134 Ventura Freeway; thence easterly along the Route 134 Ventura Freeway to the intersection with the Route 210 Foothill Freeway; thence easterly along the Route 210 Foothill Freeway to the intersection with Los Robles Avenue; thence northerly along Los Robles Avenue to the intersection with Orange Grove Boulevard; thence easterly along Orange Grove Boulevard to the intersection with El Molino Avenue; thence southerly along El Molino Avenue to the intersection with Maple Street; thence easterly along Maple Street to the intersection with Lake Avenue; thence southerly along Lake Avenue to the intersection with Colorado Boulevard; thence westerly along Colorado Boulevard to the point of beginning.

#### "1.20.050 District No. 4.

District No. 4 shall be as follows:

All that portion of the city lying within the boundaries of the following described line: Beginning at the intersection of Colorado Boulevard and Oak Avenue; thence northerly along Oak Avenue to the intersection with the Route 210 Foothill Freeway; thence westerly along the Route 210 Foothill Freeway to the intersection with Palo Verde Avenue; thence northerly along Palo Verde Avenue to the intersection with Mountain Street; thence easterly along Mountain Street to the intersection with Craig Avenue; thence northerly along Craig Avenue to the intersection with Casa Grande Street; thence easterly along Casa Grande Street to the intersection with Martelo Avenue; thence northerly along Martelo Avenue to the intersection with the northerly city boundary; thence along said city boundary in a

generally easterly, northerly, southeasterly, northeasterly, southerly, northerly, easterly, southerly, westerly, southerly, westerly, southerly and northwesterly direction, in its various courses to the intersection with San Gabriel Boulevard; thence northerly along San Gabriel Boulevard to the intersection with Colorado Boulevard; thence westerly along Colorado Boulevard to the point of beginning.

#### "1.20.060 District No. 5.

District No. 5 shall be as follows:

All that portion of the city lying within the boundaries of the following described line: Beginning at the intersection of the Route 134 Ventura Freeway and Fair Oaks Avenue; thence northerly along Fair Oaks Avenue to the intersection with Orange Grove Boulevard; thence easterly along Orange Grove Boulevard to the intersection with Worcester Avenue; thence northerly along Worcester Avenue to the intersection with Mountain Street; thence easterly along Mountain Street to the intersection with Garfield Avenue; thence northerly along Garfield Avenue to the intersection with Douglas Street; thence easterly along Douglas Street to the intersection with Los Robles Avenue; thence southerly along Los Robles Avenue to the intersection with Jackson Street; thence easterly along Jackson Street to the intersection with El Molino Avenue; thence northerly along El Molino Avenue to the intersection with Rio Grande Street; thence easterly along Rio Grande Street to the intersection with Lake Avenue; thence southerly along Lake Avenue to the intersection with Claremont Street; thence easterly along Claremont Street to the intersection with Catalina Avenue; thence southerly along Catalina Avenue to the intersection with Mountain Street; thence easterly along Mountain Street to the intersection with Michigan Avenue; thence southerly along Michigan Avenue to the intersection with Orange Grove Boulevard; thence

District No. 6 shall be as follows:

All that portion of the city lying within the boundaries of the following described line: Beginning at the intersection of the Pasadena Freeway with the southerly city boundary; thence along said city boundary in a generally southerly, westerly, northerly, westerly, northerly and easterly direction, in its various courses, to the intersection with Oak Grove Drive; thence easterly along Oak Grove Drive to the intersection with the Arroyo Seco Flood Control Channel; thence southerly along the Arroyo Seco Flood Control Channel to the intersection with the Route 134 Ventura Freeway; thence easterly along the Route 134 Ventura Freeway to the intersection with the Orange Grove Boulevard offramp from the Route 134 Ventura Freeway; thence easterly along the Orange Grove Boulevard offramp

from the Route 134 Ventura Freeway to the intersection with Colorado Boulevard; thence easterly along Colorado Boulevard to the intersection with El Molino Avenue; thence southerly along El Molino Avenue to the intersection with California Boulevard; thence westerly along California Boulevard to the intersection with Marengo Avenue; thence southerly along Marengo Avenue to Glenarm Street; thence westerly along Glenarm Street to the Pasadena Freeway; thence southerly along the Pasadena Freeway to the point of beginning.

#### "1.20.080 District No. 7.

District No. 7 shall be as follows:

All that portion of the city lying within the boundaries of the following described line: Beginning at the intersection of Glenarm Street and Marengo Avenue; thence northerly along Marengo Avenue to the intersection with California Boulevard; thence easterly along California Boulevard to the intersection with El Molino Avenue; thence northerly along El Molino Avenue to the intersection with Colorado Boulevard; thence easterly along Colorado Boulevard to the intersection with San Gabriel Boulevard; thence southerly along San Gabriel Boulevard to the intersection with the southerly city boundary; thence along said city boundary in a generally westerly, southerly, westerly, southerly and westerly direction, in its various courses, to the intersection with the Pasadena Freeway; thence northerly along the Pasadena Freeway to the intersection with Glenarm Street; thence easterly along Glenarm Street to the point of beginning.
