#### TITLE OF PROPOSED ORDINANCE:

AN ORDINANCE OF THE CITY OF PASADENA GRANTING NON-EXCLUSIVE FRANCHISES FOR SOLID WASTE COLLECTION TO 17 APPLICANTS.

#### PURPOSE OF ORDINANCE:

On July 22, 2002, the City Council held a public hearing on each of the seventeen (17) applications for non-exclusive solid waste franchises. All applications were subsequently approved by the City Council which directed the City Attorney and staff to prepare the necessary ordinance for the approved applications and authorized the City Manager to enter into the franchise agreements.

In the intervening time period, amendments were prepared to Chapter 8.61 of the Pasadena Municipal Code which, among other things, strengthened the recycling diversion requirements. Specific minimum recycling goals are contract requirements with liquidated damage provisions for failure to meet the minimum. The applicants have indicated an understanding of these requirements and have agreed to meet them.

Each franchise is for a period of one year, with up to three additional renewal terms at the option of the City Manager. Each franchise is to commence as of January 1, 2003 if a written franchise agreement is in place and the franchisee otherwise meets all of the requirements for conducting this business in the City of Pasadena.

AN ORDINANCE OF THE CITY OF PASADENA GRANTING NON-EXCLUSIVE FRANCHISES FOR SOLID WASTE COLLECTION TO 17 APPLICANTS.

WHEREAS, on July 22, 2002, the City Council of the City of Pasadena considered applications for a non-exclusive solid waste collection franchise and adopted Resolution No. 8095, after determining that said applications comply with Chapter 8.61 of the Pasadena Municipal Code; and

WHEREAS, said Resolution was duly published on April 26, 2002, and;

WHEREAS, a duly-noticed public hearing pursuant to said Resolution was held on July 22, 2002 for the applications; and

WHEREAS, after reviewing each application, and after public hearing, it was determined that specific applicants comply with Chapter 8.61 of the Pasadena Municipal Code and have agreed to comply with amendments to this Chapter relating to, among other things, required recycling diversion rates.

NOW THEREFORE, the People of the City of Pasadena ordain as follows:

SECTION 1. This ordinance, due to its length and the corresponding costs of publication, will be published by title and summary as permitted by Section 508 of the Charter. The approved summary of this ordinance reads as follows:
