AN ORDINANCE OF THE CITY OF PASADENA AMENDING VARIOUS CHAPTERS OF TITLE 2 OF THE PASADENA MUNICIPAL CODE TO REVISE THE SCHEDULE FOR SUBMITTAL OF ANNUAL REPORTS FROM ADVISORY COMMISSIONS

The People of the City of Pasadena ordain as follows:

SECTION 1. This ordinance, due to its length and the corresponding costs of publication, will be published by title and summary as permitted by Section 508 of the Charter. The approved summary of this ordinance reads as follows:

"SUMMARY

The purpose of Ordinance No. _____ is to revise Title II of the Pasadena Municipal Code to require that annual reports from advisory commissions be submitted to the City Council by September 1 rather than the current schedule of October 31. The advisory commissions affected are:

The commission shall submit an annual report and workplan to the city council no later than September 1st of each year. Attendance records of members shall be included as part of the annual report."

The commission shall submit an annual report and workplan to the city council no later than September 1st of each year. Attendance records of members shall be included as part of the annual report."

The commission shall submit an annual report and workplan to the city council no later than September 1st of each year. Attendance records of members shall be included as part of the annual report."

SECTION 18. Section 2.135.090 of said code (Transportation Advisory Commission) is amended to read:

"2.135.090 Annual report.

The commission shall submit an annual report and workplan to the city council no later than September 1st of each year. Attendance records of members shall be included as part of the annual report."

SECTION 19. Section 2.140.090 of said code (Utility Advisory Commission) is amended to read:

"2.140.090 Annual report.

The commission shall submit an annual report and workplan to the city council no later than September 1st of each year. Attendance records of members shall be included as part of the annual report."

SECTION 20. The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published by title and summary.

SECTION 21. This ordinance shall take effect upon its publication by title and summary.


